1 AMENDMENT TO SENATE BILL 3952

2 AMENDMENT NO. _____. Amend Senate Bill 3952 as follows:

3 on page 1, lines 5 and 6, by replacing "and 11-74.3-6" with
4 "11-74.3-6, and 11-74.4-3.5"; and

5 on page 37, immediately below line 23, by inserting the
6 following:

7 "(65 ILCS 5/11-74.4-3.5)

8 Sec. 11-74.4-3.5. Completion dates for redevelopment
9 projects.

10 (a) Unless otherwise stated in this Section, the estimated
11 dates of completion of the redevelopment project and retirement
12 of obligations issued to finance redevelopment project costs
13 (including refunding bonds under Section 11-74.4-7) may not be
14 later than December 31 of the year in which the payment to the
15 municipal treasurer, as provided in subsection (b) of Section

1 11-74.4-8 of this Act, is to be made with respect to ad valorem
2 taxes levied in the 23rd calendar year after the year in which
3 the ordinance approving the redevelopment project area was
4 adopted if the ordinance was adopted on or after January 15,
5 1981.

6 (b) The estimated dates of completion of the redevelopment
7 project and retirement of obligations issued to finance
8 redevelopment project costs (including refunding bonds under
9 Section 11-74.4-7) may not be later than December 31 of the
10 year in which the payment to the municipal treasurer as
11 provided in subsection (b) of Section 11-74.4-8 of this Act is
12 to be made with respect to ad valorem taxes levied in the 32nd
13 calendar year after the year in which the ordinance approving
14 the redevelopment project area was adopted, if the ordinance
15 was adopted on September 9, 1999 by the Village of Downs.

16 The estimated dates of completion of the redevelopment
17 project and retirement of obligations issued to finance
18 redevelopment project costs (including refunding bonds under
19 Section 11-74.4-7) may not be later than December 31 of the
20 year in which the payment to the municipal treasurer as
21 provided in subsection (b) of Section 11-74.4-8 of this Act is
22 to be made with respect to ad valorem taxes levied in the 33rd
23 calendar year after the year in which the ordinance approving
24 the redevelopment project area was adopted, if the ordinance
25 was adopted on May 20, 1985 by the Village of Wheeling.

26 (c) The estimated dates of completion of the redevelopment

1 project and retirement of obligations issued to finance
2 redevelopment project costs (including refunding bonds under
3 Section 11-74.4-7) may not be later than December 31 of the
4 year in which the payment to the municipal treasurer as
5 provided in subsection (b) of Section 11-74.4-8 of this Act is
6 to be made with respect to ad valorem taxes levied in the 35th
7 calendar year after the year in which the ordinance approving
8 the redevelopment project area was adopted:

9 (1) if the ordinance was adopted before January 15,
10 1981;

11 (2) if the ordinance was adopted in December 1983,
12 April 1984, July 1985, or December 1989;

13 (3) if the ordinance was adopted in December 1987 and
14 the redevelopment project is located within one mile of
15 Midway Airport;

16 (4) if the ordinance was adopted before January 1, 1987
17 by a municipality in Mason County;

18 (5) if the municipality is subject to the Local
19 Government Financial Planning and Supervision Act or the
20 Financially Distressed City Law;

3 population in 1990 of less than 34,000 and for which at
4 least \$250,000 of tax increment bonds were authorized on

8 (d) For redevelopment project areas for which bonds were
9 issued before July 29, 1991, or for which contracts were
10 entered into before June 1, 1988, in connection with a
11 redevelopment project in the area within the State Sales Tax
12 Boundary, the estimated dates of completion of the
13 redevelopment project and retirement of obligations to finance
14 redevelopment project costs (including refunding bonds under
15 Section 11-74.4-7) may be extended by municipal ordinance to
16 December 31, 2013. The termination procedures of subsection (b)
17 of Section 11-74.4-8 are not required for these redevelopment
18 project areas in 2009 but are required in 2013. The extension
19 allowed by Public Act 87-1272 shall not apply to real property
20 tax increment allocation financing under Section 11-74.4-8.

21 (e) Those dates, for purposes of real property tax
22 increment allocation financing pursuant to Section 11-74.4-8
23 only, shall be not more than 35 years for redevelopment project
24 areas that were adopted on or after December 16, 1986 and for
25 which at least \$8 million worth of municipal bonds were
26 authorized on or after December 19, 1989 but before January 1,

1 1990; provided that the municipality elects to extend the life
2 of the redevelopment project area to 35 years by the adoption
3 of an ordinance after at least 14 but not more than 30 days'
4 written notice to the taxing bodies, that would otherwise
5 constitute the joint review board for the redevelopment project
6 area, before the adoption of the ordinance.

7 (f) Those dates, for purposes of real property tax
8 increment allocation financing pursuant to Section 11-74.4-8
9 only, shall be not more than 35 years for redevelopment project
10 areas that were established on or after December 1, 1981 but
11 before January 1, 1982 and for which at least \$1,500,000 worth
12 of tax increment revenue bonds were authorized on or after
13 September 30, 1990 but before July 1, 1991; provided that the
14 municipality elects to extend the life of the redevelopment
15 project area to 35 years by the adoption of an ordinance after
16 at least 14 but not more than 30 days' written notice to the
17 taxing bodies, that would otherwise constitute the joint review
18 board for the redevelopment project area, before the adoption
19 of the ordinance.

20 (g) In consolidating the material relating to completion
21 dates from Sections 11-74.4-3 and 11-74.4-7 into this Section,
22 it is not the intent of the General Assembly to make any
23 substantive change in the law, except for the extension of the
24 completion dates for the City of Aurora, the Village of Milan,
25 the City of West Frankfort, the Village of Libertyville, and
26 the Village of Hoffman Estates set forth under items (67),

1 (68), (69), (70), and (71) of subsection (c) of this Section.
