#### SYNOPSIS AS INTRODUCED:

235 ILCS 5/6-15

from Ch. 43, par. 130

Amends the Liquor Control Act of 1934. Provides that, in accordance with a license issued under the Act, alcoholic liquor may be sold, served, or delivered in buildings and facilities under the control of the Department of Natural Resources during events or activities lasting 7 continuous days upon the written approval of the Director of Natural Resources acting as the controlling government authority. Makes other changes. Effective immediately.

1 AN ACT concerning liquor.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Liquor Control Act of 1934 is amended by  
5 changing Section 6-15 as follows:

6 (235 ILCS 5/6-15) (from Ch. 43, par. 130)

7 Sec. 6-15. No alcoholic liquors shall be sold or delivered  
8 in any building belonging to or under the control of the State  
9 or any political subdivision thereof except as provided in this  
10 Act. The corporate authorities of any city, village,  
11 incorporated town or township may provide by ordinance,  
12 however, that alcoholic liquor may be sold or delivered in any  
13 specifically designated building belonging to or under the  
14 control of the municipality or township, or in any building  
15 located on land under the control of the municipality; provided  
16 that such township complies with all applicable local  
17 ordinances in any incorporated area of the township. Alcoholic  
18 liquor may be delivered to and sold under the authority of a  
19 special use permit on any property owned by a conservation  
20 district organized under the Conservation District Act,  
21 provided that (i) the alcoholic liquor is sold only at an event  
22 authorized by the governing board of the conservation district,  
23 (ii) the issuance of the special use permit is authorized by

1 the local liquor control commissioner of the territory in which  
2 the property is located, and (iii) the special use permit  
3 authorizes the sale of alcoholic liquor for one day or less.  
4 Alcoholic liquors may be delivered to and sold at any airport  
5 belonging to or under the control of a municipality of more  
6 than 25,000 inhabitants, or in any building or on any golf  
7 course owned by a park district organized under the Park  
8 District Code, subject to the approval of the governing board  
9 of the district, or in any building or on any golf course owned  
10 by a forest preserve district organized under the Downstate  
11 Forest Preserve District Act, subject to the approval of the  
12 governing board of the district, or on the grounds within 500  
13 feet of any building owned by a forest preserve district  
14 organized under the Downstate Forest Preserve District Act  
15 during times when food is dispensed for consumption within 500  
16 feet of the building from which the food is dispensed, subject  
17 to the approval of the governing board of the district, or in a  
18 building owned by a Local Mass Transit District organized under  
19 the Local Mass Transit District Act, subject to the approval of  
20 the governing Board of the District, or in Bicentennial Park,  
21 or on the premises of the City of Mendota Lake Park located  
22 adjacent to Route 51 in Mendota, Illinois, or on the premises  
23 of Camden Park in Milan, Illinois, or in the community center  
24 owned by the City of Loves Park that is located at 1000 River  
25 Park Drive in Loves Park, Illinois, or, in connection with the  
26 operation of an established food serving facility during times

1 when food is dispensed for consumption on the premises, and at  
2 the following aquarium and museums located in public parks: Art  
3 Institute of Chicago, Chicago Academy of Sciences, Chicago  
4 Historical Society, Field Museum of Natural History, Museum of  
5 Science and Industry, DuSable Museum of African American  
6 History, John G. Shedd Aquarium and Adler Planetarium, or at  
7 Lakeview Museum of Arts and Sciences in Peoria, or in  
8 connection with the operation of the facilities of the Chicago  
9 Zoological Society or the Chicago Horticultural Society on land  
10 owned by the Forest Preserve District of Cook County, or on any  
11 land used for a golf course or for recreational purposes owned  
12 by the Forest Preserve District of Cook County, subject to the  
13 control of the Forest Preserve District Board of Commissioners  
14 and applicable local law, provided that dram shop liability  
15 insurance is provided at maximum coverage limits so as to hold  
16 the District harmless from all financial loss, damage, and  
17 harm, or in any building located on land owned by the Chicago  
18 Park District if approved by the Park District Commissioners,  
19 or on any land used for a golf course or for recreational  
20 purposes and owned by the Illinois International Port District  
21 if approved by the District's governing board, or at any  
22 airport, golf course, faculty center, or facility in which  
23 conference and convention type activities take place belonging  
24 to or under control of any State university or public community  
25 college district, provided that with respect to a facility for  
26 conference and convention type activities alcoholic liquors

1 shall be limited to the use of the convention or conference  
2 participants or participants in cultural, political or  
3 educational activities held in such facilities, and provided  
4 further that the faculty or staff of the State university or a  
5 public community college district, or members of an  
6 organization of students, alumni, faculty or staff of the State  
7 university or a public community college district are active  
8 participants in the conference or convention, or in Memorial  
9 Stadium on the campus of the University of Illinois at  
10 Urbana-Champaign during games in which the Chicago Bears  
11 professional football team is playing in that stadium during  
12 the renovation of Soldier Field, not more than one and a half  
13 hours before the start of the game and not after the end of the  
14 third quarter of the game, or in the Pavilion Facility on the  
15 campus of the University of Illinois at Chicago during games in  
16 which the Chicago Storm professional soccer team is playing in  
17 that facility, not more than one and a half hours before the  
18 start of the game and not after the end of the third quarter of  
19 the game, or in the Pavilion Facility on the campus of the  
20 University of Illinois at Chicago during games in which the  
21 WNBA professional women's basketball team is playing in that  
22 facility, not more than one and a half hours before the start  
23 of the game and not after the 10-minute mark of the second half  
24 of the game, or by a catering establishment which has rented  
25 facilities from a board of trustees of a public community  
26 college district, or in a restaurant that is operated by a

1 commercial tenant in the North Campus Parking Deck building  
2 that (1) is located at 1201 West University Avenue, Urbana,  
3 Illinois and (2) is owned by the Board of Trustees of the  
4 University of Illinois, or, if approved by the District board,  
5 on land owned by the Metropolitan Sanitary District of Greater  
6 Chicago and leased to others for a term of at least 20 years.  
7 Nothing in this Section precludes the sale or delivery of  
8 alcoholic liquor in the form of original packaged goods in  
9 premises located at 500 S. Racine in Chicago belonging to the  
10 University of Illinois and used primarily as a grocery store by  
11 a commercial tenant during the term of a lease that predates  
12 the University's acquisition of the premises; but the  
13 University shall have no power or authority to renew, transfer,  
14 or extend the lease with terms allowing the sale of alcoholic  
15 liquor; and the sale of alcoholic liquor shall be subject to  
16 all local laws and regulations. After the acquisition by  
17 Winnebago County of the property located at 404 Elm Street in  
18 Rockford, a commercial tenant who sold alcoholic liquor at  
19 retail on a portion of the property under a valid license at  
20 the time of the acquisition may continue to do so for so long  
21 as the tenant and the County may agree under existing or future  
22 leases, subject to all local laws and regulations regarding the  
23 sale of alcoholic liquor. Each facility shall provide dram shop  
24 liability in maximum insurance coverage limits so as to save  
25 harmless the State, municipality, State university, airport,  
26 golf course, faculty center, facility in which conference and

1 convention type activities take place, park district, Forest  
2 Preserve District, public community college district,  
3 aquarium, museum, or sanitary district from all financial loss,  
4 damage or harm. Alcoholic liquors may be sold at retail in  
5 buildings of golf courses owned by municipalities in connection  
6 with the operation of an established food serving facility  
7 during times when food is dispensed for consumption upon the  
8 premises. Alcoholic liquors may be delivered to and sold at  
9 retail in any building owned by a fire protection district  
10 organized under the Fire Protection District Act, provided that  
11 such delivery and sale is approved by the board of trustees of  
12 the district, and provided further that such delivery and sale  
13 is limited to fundraising events and to a maximum of 6 events  
14 per year.

15 Alcoholic liquors may be served or sold in buildings under  
16 the control of the Board of Trustees of the University of  
17 Illinois for events that the Board may determine are public  
18 events and not related student activities. The Board of  
19 Trustees shall issue a written policy within 6 months of the  
20 effective date of this amendatory Act of the 95th General  
21 Assembly concerning the types of events that would be eligible  
22 for an exemption. Thereafter, the Board of Trustees may issue  
23 revised, updated, new, or amended policies as it deems  
24 necessary and appropriate. In preparing its written policy, the  
25 Board of Trustees shall, among other factors it considers  
26 relevant and important, give consideration to the following:

1 (i) whether the event is a student activity or student related  
2 activity; (ii) whether the physical setting of the event is  
3 conducive to control of liquor sales and distribution; (iii)  
4 the ability of the event operator to ensure that the sale or  
5 serving of alcoholic liquors and the demeanor of the  
6 participants are in accordance with State law and University  
7 policies; (iv) regarding the anticipated attendees at the  
8 event, the relative proportion of individuals under the age of  
9 21 to individuals age 21 or older; (v) the ability of the venue  
10 operator to prevent the sale or distribution of alcoholic  
11 liquors to individuals under the age of 21; (vi) whether the  
12 event prohibits participants from removing alcoholic beverages  
13 from the venue; and (vii) whether the event prohibits  
14 participants from providing their own alcoholic liquors to the  
15 venue. In addition, any policy submitted by the Board of  
16 Trustees to the Illinois Liquor Control Commission must require  
17 that any event at which alcoholic liquors are served or sold in  
18 buildings under the control of the Board of Trustees shall  
19 require the prior written approval of the Office of the  
20 Chancellor for the University campus where the event is  
21 located. The Board of Trustees shall submit its policy, and any  
22 subsequently revised, updated, new, or amended policies, to the  
23 Illinois Liquor Control Commission, and any University event,  
24 or location for an event, exempted under such policies shall  
25 apply for a license under the applicable Sections of this Act.

26 Alcoholic liquor may be delivered to and sold at retail in



1 the Dorchester Senior Business Center owned by the Village of  
2 Dolton if the alcoholic liquor is sold or dispensed only in  
3 connection with organized functions for which the planned  
4 attendance is 20 or more persons, and if the person or facility  
5 selling or dispensing the alcoholic liquor has provided dram  
6 shop liability insurance in maximum limits so as to hold  
7 harmless the Village of Dolton and the State from all financial  
8 loss, damage and harm.

9 Alcoholic liquors may be delivered to and sold at retail in  
10 any building used as an Illinois State Armory provided:

11 (i) the Adjutant General's written consent to the  
12 issuance of a license to sell alcoholic liquor in such  
13 building is filed with the Commission;

14 (ii) the alcoholic liquor is sold or dispensed only in  
15 connection with organized functions held on special  
16 occasions;

17 (iii) the organized function is one for which the  
18 planned attendance is 25 or more persons; and

19 (iv) the facility selling or dispensing the alcoholic  
20 liquors has provided dram shop liability insurance in  
21 maximum limits so as to save harmless the facility and the  
22 State from all financial loss, damage or harm.

23 Alcoholic liquors may be delivered to and sold at retail in  
24 the Chicago Civic Center, provided that:

25 (i) the written consent of the Public Building  
26 Commission which administers the Chicago Civic Center is

1 filed with the Commission;

2 (ii) the alcoholic liquor is sold or dispensed only in  
3 connection with organized functions held on special  
4 occasions;

5 (iii) the organized function is one for which the  
6 planned attendance is 25 or more persons;

7 (iv) the facility selling or dispensing the alcoholic  
8 liquors has provided dram shop liability insurance in  
9 maximum limits so as to hold harmless the Civic Center, the  
10 City of Chicago and the State from all financial loss,  
11 damage or harm; and

12 (v) all applicable local ordinances are complied with.

13 Alcoholic liquors may be delivered or sold in any building  
14 belonging to or under the control of any city, village or  
15 incorporated town where more than 75% of the physical  
16 properties of the building is used for commercial or  
17 recreational purposes, and the building is located upon a pier  
18 extending into or over the waters of a navigable lake or stream  
19 or on the shore of a navigable lake or stream. ~~Alcoholic liquor~~  
20 ~~may be sold in buildings under the control of the Department of~~  
21 ~~Natural Resources when written consent to the issuance of a~~  
22 ~~license to sell alcoholic liquor in such buildings is filed~~  
23 ~~with the Commission by the Department of Natural Resources. In~~  
24 ~~accordance with a license issued under this Act, alcoholic~~  
25 ~~Alcoholic~~ liquor may be sold, served, or delivered in buildings  
26 and facilities under the control of the Department of Natural

1 Resources during events or activities lasting no more than 7  
2 continuous days upon the written approval of the Director of  
3 Natural Resources acting as the controlling government  
4 authority. The Director of Natural Resources may specify  
5 conditions on that approval, including but not limited to  
6 requirements for insurance and hours of operation.  
7 Notwithstanding any other provision of this Act, alcoholic  
8 liquor sold by a United States Army Corps of Engineers or  
9 Department of Natural Resources concessionaire who was  
10 operating on June 1, 1991 for on-premises consumption only is  
11 not subject to the provisions of Articles IV and IX. Beer and  
12 wine may be sold on the premises of the Joliet Park District  
13 Stadium owned by the Joliet Park District when written consent  
14 to the issuance of a license to sell beer and wine in such  
15 premises is filed with the local liquor commissioner by the  
16 Joliet Park District. Beer and wine may be sold in buildings on  
17 the grounds of State veterans' homes when written consent to  
18 the issuance of a license to sell beer and wine in such  
19 buildings is filed with the Commission by the Department of  
20 Veterans' Affairs, and the facility shall provide dram shop  
21 liability in maximum insurance coverage limits so as to save  
22 the facility harmless from all financial loss, damage or harm.  
23 Such liquors may be delivered to and sold at any property owned  
24 or held under lease by a Metropolitan Pier and Exposition  
25 Authority or Metropolitan Exposition and Auditorium Authority.

26 Beer and wine may be sold and dispensed at professional

1 sporting events and at professional concerts and other  
2 entertainment events conducted on premises owned by the Forest  
3 Preserve District of Kane County, subject to the control of the  
4 District Commissioners and applicable local law, provided that  
5 dram shop liability insurance is provided at maximum coverage  
6 limits so as to hold the District harmless from all financial  
7 loss, damage and harm.

8 Nothing in this Section shall preclude the sale or delivery  
9 of beer and wine at a State or county fair or the sale or  
10 delivery of beer or wine at a city fair in any otherwise lawful  
11 manner.

12 Alcoholic liquors may be sold at retail in buildings in  
13 State parks under the control of the Department of Natural  
14 Resources, provided:

15 a. the State park has overnight lodging facilities with  
16 some restaurant facilities or, not having overnight  
17 lodging facilities, has restaurant facilities which serve  
18 complete luncheon and dinner or supper meals,

19 b. consent to the issuance of a license to sell  
20 alcoholic liquors in the buildings has been filed with the  
21 commission by the Department of Natural Resources, and

22 c. the alcoholic liquors are sold by the State park  
23 lodge or restaurant concessionaire only during the hours  
24 from 11 o'clock a.m. until 12 o'clock midnight.  
25 Notwithstanding any other provision of this Act, alcoholic  
26 liquor sold by the State park or restaurant concessionaire

1 is not subject to the provisions of Articles IV and IX.

2 Alcoholic liquors may be sold at retail in buildings on  
3 properties under the control of the Historic Sites and  
4 Preservation Division of the Historic Preservation Agency or  
5 the Abraham Lincoln Presidential Library and Museum provided:

6 a. the property has overnight lodging facilities with  
7 some restaurant facilities or, not having overnight  
8 lodging facilities, has restaurant facilities which serve  
9 complete luncheon and dinner or supper meals,

10 b. consent to the issuance of a license to sell  
11 alcoholic liquors in the buildings has been filed with the  
12 commission by the Historic Sites and Preservation Division  
13 of the Historic Preservation Agency or the Abraham Lincoln  
14 Presidential Library and Museum, and

15 c. the alcoholic liquors are sold by the lodge or  
16 restaurant concessionaire only during the hours from 11  
17 o'clock a.m. until 12 o'clock midnight.

18 The sale of alcoholic liquors pursuant to this Section does  
19 not authorize the establishment and operation of facilities  
20 commonly called taverns, saloons, bars, cocktail lounges, and  
21 the like except as a part of lodge and restaurant facilities in  
22 State parks or golf courses owned by Forest Preserve Districts  
23 with a population of less than 3,000,000 or municipalities or  
24 park districts.

25 Alcoholic liquors may be sold at retail in the Springfield  
26 Administration Building of the Department of Transportation

1 and the Illinois State Armory in Springfield; provided, that  
2 the controlling government authority may consent to such sales  
3 only if

4 a. the request is from a not-for-profit organization;

5 b. such sales would not impede normal operations of the  
6 departments involved;

7 c. the not-for-profit organization provides dram shop  
8 liability in maximum insurance coverage limits and agrees  
9 to defend, save harmless and indemnify the State of  
10 Illinois from all financial loss, damage or harm;

11 d. no such sale shall be made during normal working  
12 hours of the State of Illinois; and

13 e. the consent is in writing.

14 Alcoholic liquors may be sold at retail in buildings in  
15 recreational areas of river conservancy districts under the  
16 control of, or leased from, the river conservancy districts.  
17 Such sales are subject to reasonable local regulations as  
18 provided in Article IV; however, no such regulations may  
19 prohibit or substantially impair the sale of alcoholic liquors  
20 on Sundays or Holidays.

21 Alcoholic liquors may be provided in long term care  
22 facilities owned or operated by a county under Division 5-21 or  
23 5-22 of the Counties Code, when approved by the facility  
24 operator and not in conflict with the regulations of the  
25 Illinois Department of Public Health, to residents of the  
26 facility who have had their consumption of the alcoholic

1 liquors provided approved in writing by a physician licensed to  
2 practice medicine in all its branches.

3 Alcoholic liquors may be delivered to and dispensed in  
4 State housing assigned to employees of the Department of  
5 Corrections. No person shall furnish or allow to be furnished  
6 any alcoholic liquors to any prisoner confined in any jail,  
7 reformatory, prison or house of correction except upon a  
8 physician's prescription for medicinal purposes.

9 Alcoholic liquors may be sold at retail or dispensed at the  
10 Willard Ice Building in Springfield, at the State Library in  
11 Springfield, and at Illinois State Museum facilities by (1) an  
12 agency of the State, whether legislative, judicial or  
13 executive, provided that such agency first obtains written  
14 permission to sell or dispense alcoholic liquors from the  
15 controlling government authority, or by (2) a not-for-profit  
16 organization, provided that such organization:

17 a. Obtains written consent from the controlling  
18 government authority;

19 b. Sells or dispenses the alcoholic liquors in a manner  
20 that does not impair normal operations of State offices  
21 located in the building;

22 c. Sells or dispenses alcoholic liquors only in  
23 connection with an official activity in the building;

24 d. Provides, or its catering service provides, dram  
25 shop liability insurance in maximum coverage limits and in  
26 which the carrier agrees to defend, save harmless and

1 indemnify the State of Illinois from all financial loss,  
2 damage or harm arising out of the selling or dispensing of  
3 alcoholic liquors.

4 Nothing in this Act shall prevent a not-for-profit  
5 organization or agency of the State from employing the services  
6 of a catering establishment for the selling or dispensing of  
7 alcoholic liquors at authorized functions.

8 The controlling government authority for the Willard Ice  
9 Building in Springfield shall be the Director of the Department  
10 of Revenue. The controlling government authority for Illinois  
11 State Museum facilities shall be the Director of the Illinois  
12 State Museum. The controlling government authority for the  
13 State Library in Springfield shall be the Secretary of State.

14 Alcoholic liquors may be delivered to and sold at retail or  
15 dispensed at any facility, property or building under the  
16 jurisdiction of the Historic Sites and Preservation Division of  
17 the Historic Preservation Agency or the Abraham Lincoln  
18 Presidential Library and Museum where the delivery, sale or  
19 dispensing is by (1) an agency of the State, whether  
20 legislative, judicial or executive, provided that such agency  
21 first obtains written permission to sell or dispense alcoholic  
22 liquors from a controlling government authority, or by (2) an  
23 individual or organization provided that such individual or  
24 organization:

25 a. Obtains written consent from the controlling  
26 government authority;



1           b. Sells or dispenses the alcoholic liquors in a manner  
2           that does not impair normal workings of State offices or  
3           operations located at the facility, property or building;

4           c. Sells or dispenses alcoholic liquors only in  
5           connection with an official activity of the individual or  
6           organization in the facility, property or building;

7           d. Provides, or its catering service provides, dram  
8           shop liability insurance in maximum coverage limits and in  
9           which the carrier agrees to defend, save harmless and  
10          indemnify the State of Illinois from all financial loss,  
11          damage or harm arising out of the selling or dispensing of  
12          alcoholic liquors.

13          The controlling government authority for the Historic  
14          Sites and Preservation Division of the Historic Preservation  
15          Agency shall be the Director of the Historic Sites and  
16          Preservation, and the controlling government authority for the  
17          Abraham Lincoln Presidential Library and Museum shall be the  
18          Director of the Abraham Lincoln Presidential Library and  
19          Museum.

20          Alcoholic liquors may be delivered to and sold at retail or  
21          dispensed for consumption at the Michael Bilandic Building at  
22          160 North LaSalle Street, Chicago IL 60601, after the normal  
23          business hours of any day care or child care facility located  
24          in the building, by (1) a commercial tenant or subtenant  
25          conducting business on the premises under a lease made pursuant  
26          to Section 405-315 of the Department of Central Management

1 Services Law (20 ILCS 405/405-315), provided that such tenant  
2 or subtenant who accepts delivery of, sells, or dispenses  
3 alcoholic liquors shall procure and maintain dram shop  
4 liability insurance in maximum coverage limits and in which the  
5 carrier agrees to defend, indemnify, and save harmless the  
6 State of Illinois from all financial loss, damage, or harm  
7 arising out of the delivery, sale, or dispensing of alcoholic  
8 liquors, or by (2) an agency of the State, whether legislative,  
9 judicial, or executive, provided that such agency first obtains  
10 written permission to accept delivery of and sell or dispense  
11 alcoholic liquors from the Director of Central Management  
12 Services, or by (3) a not-for-profit organization, provided  
13 that such organization:

14 a. obtains written consent from the Department of  
15 Central Management Services;

16 b. accepts delivery of and sells or dispenses the  
17 alcoholic liquors in a manner that does not impair normal  
18 operations of State offices located in the building;

19 c. accepts delivery of and sells or dispenses alcoholic  
20 liquors only in connection with an official activity in the  
21 building; and

22 d. provides, or its catering service provides, dram  
23 shop liability insurance in maximum coverage limits and in  
24 which the carrier agrees to defend, save harmless, and  
25 indemnify the State of Illinois from all financial loss,  
26 damage, or harm arising out of the selling or dispensing of

1 alcoholic liquors.

2 Nothing in this Act shall prevent a not-for-profit  
3 organization or agency of the State from employing the services  
4 of a catering establishment for the selling or dispensing of  
5 alcoholic liquors at functions authorized by the Director of  
6 Central Management Services.

7 Alcoholic liquors may be sold at retail or dispensed at the  
8 James R. Thompson Center in Chicago, subject to the provisions  
9 of Section 7.4 of the State Property Control Act, and 222 South  
10 College Street in Springfield, Illinois by (1) a commercial  
11 tenant or subtenant conducting business on the premises under a  
12 lease or sublease made pursuant to Section 405-315 of the  
13 Department of Central Management Services Law (20 ILCS  
14 405/405-315), provided that such tenant or subtenant who sells  
15 or dispenses alcoholic liquors shall procure and maintain dram  
16 shop liability insurance in maximum coverage limits and in  
17 which the carrier agrees to defend, indemnify and save harmless  
18 the State of Illinois from all financial loss, damage or harm  
19 arising out of the sale or dispensing of alcoholic liquors, or  
20 by (2) an agency of the State, whether legislative, judicial or  
21 executive, provided that such agency first obtains written  
22 permission to sell or dispense alcoholic liquors from the  
23 Director of Central Management Services, or by (3) a  
24 not-for-profit organization, provided that such organization:

25 a. Obtains written consent from the Department of  
26 Central Management Services;

1           b. Sells or dispenses the alcoholic liquors in a manner  
2           that does not impair normal operations of State offices  
3           located in the building;

4           c. Sells or dispenses alcoholic liquors only in  
5           connection with an official activity in the building;

6           d. Provides, or its catering service provides, dram  
7           shop liability insurance in maximum coverage limits and in  
8           which the carrier agrees to defend, save harmless and  
9           indemnify the State of Illinois from all financial loss,  
10          damage or harm arising out of the selling or dispensing of  
11          alcoholic liquors.

12          Nothing in this Act shall prevent a not-for-profit  
13          organization or agency of the State from employing the services  
14          of a catering establishment for the selling or dispensing of  
15          alcoholic liquors at functions authorized by the Director of  
16          Central Management Services.

17          Alcoholic liquors may be sold or delivered at any facility  
18          owned by the Illinois Sports Facilities Authority provided that  
19          dram shop liability insurance has been made available in a  
20          form, with such coverage and in such amounts as the Authority  
21          reasonably determines is necessary.

22          Alcoholic liquors may be sold at retail or dispensed at the  
23          Rockford State Office Building by (1) an agency of the State,  
24          whether legislative, judicial or executive, provided that such  
25          agency first obtains written permission to sell or dispense  
26          alcoholic liquors from the Department of Central Management

1 Services, or by (2) a not-for-profit organization, provided  
2 that such organization:

3 a. Obtains written consent from the Department of  
4 Central Management Services;

5 b. Sells or dispenses the alcoholic liquors in a manner  
6 that does not impair normal operations of State offices  
7 located in the building;

8 c. Sells or dispenses alcoholic liquors only in  
9 connection with an official activity in the building;

10 d. Provides, or its catering service provides, dram  
11 shop liability insurance in maximum coverage limits and in  
12 which the carrier agrees to defend, save harmless and  
13 indemnify the State of Illinois from all financial loss,  
14 damage or harm arising out of the selling or dispensing of  
15 alcoholic liquors.

16 Nothing in this Act shall prevent a not-for-profit  
17 organization or agency of the State from employing the services  
18 of a catering establishment for the selling or dispensing of  
19 alcoholic liquors at functions authorized by the Department of  
20 Central Management Services.

21 Alcoholic liquors may be sold or delivered in a building  
22 that is owned by McLean County, situated on land owned by the  
23 county in the City of Bloomington, and used by the McLean  
24 County Historical Society if the sale or delivery is approved  
25 by an ordinance adopted by the county board, and the  
26 municipality in which the building is located may not prohibit

1 that sale or delivery, notwithstanding any other provision of  
2 this Section. The regulation of the sale and delivery of  
3 alcoholic liquor in a building that is owned by McLean County,  
4 situated on land owned by the county, and used by the McLean  
5 County Historical Society as provided in this paragraph is an  
6 exclusive power and function of the State and is a denial and  
7 limitation under Article VII, Section 6, subsection (h) of the  
8 Illinois Constitution of the power of a home rule municipality  
9 to regulate that sale and delivery.

10 Alcoholic liquors may be sold or delivered in any building  
11 situated on land held in trust for any school district  
12 organized under Article 34 of the School Code, if the building  
13 is not used for school purposes and if the sale or delivery is  
14 approved by the board of education.

15 Alcoholic liquors may be sold or delivered in buildings  
16 owned by the Community Building Complex Committee of Boone  
17 County, Illinois if the person or facility selling or  
18 dispensing the alcoholic liquor has provided dram shop  
19 liability insurance with coverage and in amounts that the  
20 Committee reasonably determines are necessary.

21 Alcoholic liquors may be sold or delivered in the building  
22 located at 1200 Centerville Avenue in Belleville, Illinois and  
23 occupied by either the Belleville Area Special Education  
24 District or the Belleville Area Special Services Cooperative.

25 Alcoholic liquors may be delivered to and sold at the Louis  
26 Joliet Renaissance Center, City Center Campus, located at 214

1 N. Ottawa Street, Joliet, and the Food Services/Culinary Arts  
2 Department facilities, Main Campus, located at 1215 Houbolt  
3 Road, Joliet, owned by or under the control of Joliet Junior  
4 College, Illinois Community College District No. 525.

5 Alcoholic liquors may be delivered to and sold at Triton  
6 College, Illinois Community College District No. 504.

7 Alcoholic liquors may be delivered to and sold at the  
8 building located at 446 East Hickory Avenue in Apple River,  
9 Illinois, owned by the Apple River Fire Protection District,  
10 and occupied by the Apple River Community Association if the  
11 alcoholic liquor is sold or dispensed only in connection with  
12 organized functions approved by the Apple River Community  
13 Association for which the planned attendance is 20 or more  
14 persons and if the person or facility selling or dispensing the  
15 alcoholic liquor has provided dram shop liability insurance in  
16 maximum limits so as to hold harmless the Apple River Fire  
17 Protection District, the Village of Apple River, and the Apple  
18 River Community Association from all financial loss, damage,  
19 and harm.

20 Alcoholic liquors may be delivered to and sold at the Sikia  
21 Restaurant, Kennedy King College Campus, located at 740 West  
22 63rd Street, Chicago, and at the Food Services in the Great  
23 Hall/Washburne Culinary Institute Department facility, Kennedy  
24 King College Campus, located at 740 West 63rd Street, Chicago,  
25 owned by or under the control of City Colleges of Chicago,  
26 Illinois Community College District No. 508.
