2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Municipal Code is amended by  
5 changing Section 11-42-1 as follows:

7 Sec. 11-42-1. The corporate authorities of each  
8 municipality may license, tax, and regulate all businesses  
9 located within their corporate limits ~~auctioneers, private~~

11 ~~brokers other than insurance brokers, barbers, and the keepers~~  
12 ~~or owners of lumber yards, lumber storehouses, livery stables,~~
