1 AMENDMENT TO HOUSE BILL 5914

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 5914, AS AMENDED, by  
3 replacing everything after the enacting clause with the  
4 following:

5 "Section 5. The University of Illinois Act is amended by  
6 adding Section 80 as follows:

7 (110 ILCS 305/80 new)

8 Sec. 80. Search firm prohibition. Charges for the services  
9 of an external hiring search firm may not be paid from any  
10 source of funds, except (i) in the hiring of the President of  
11 the University or (ii) in the case of when the President of the  
12 University and the Board of Trustees demonstrate a justifiable  
13 need for guidance from an individual or firm with specific  
14 expertise in the field of the hiring. The University shall  
15 implement a policy under this Section, including qualifying  
16 criteria, within 6 months after the effective date of this

1 amendatory Act of the 97th General Assembly.

2 Section 10. The Southern Illinois University Management  
3 Act is amended by adding Section 65 as follows:

4 (110 ILCS 520/65 new)

5 Sec. 65. Search firm prohibition. Charges for the services  
6 of an external hiring search firm may not be paid from any  
7 source of funds, except (i) in the hiring of the President of  
8 the University or (ii) in the case of when the President of the  
9 University and the Board demonstrate a justifiable need for  
10 guidance from an individual or firm with specific expertise in  
11 the field of the hiring. The University shall implement a  
12 policy under this Section, including qualifying criteria,  
13 within 6 months after the effective date of this amendatory Act  
14 of the 97th General Assembly.

15 Section 15. The Chicago State University Law is amended by  
16 adding Section 5-175 as follows:

17 (110 ILCS 660/5-175 new)

18 Sec. 5-175. Search firm prohibition. Charges for the  
19 services of an external hiring search firm may not be paid from  
20 any source of funds, except (i) in the hiring of the President  
21 of the University or (ii) in the case of when the President of  
22 the University and the Board demonstrate a justifiable need for

1 guidance from an individual or firm with specific expertise in  
2 the field of the hiring. The University shall implement a  
3 policy under this Section, including qualifying criteria,  
4 within 6 months after the effective date of this amendatory Act  
5 of the 97th General Assembly.

6 Section 20. The Eastern Illinois University Law is amended

9 Sec. 10-175. Search firm prohibition. Charges for the  
10 services of an external hiring search firm may not be paid from  
11 any source of funds, except (i) in the hiring of the President  
12 of the University or (ii) in the case of when the President of  
13 the University and the Board demonstrate a justifiable need for  
14 guidance from an individual or firm with specific expertise in  
15 the field of the hiring. The University shall implement a  
16 policy under this Section, including qualifying criteria,  
17 within 6 months after the effective date of this amendatory Act  
18 of the 97th General Assembly.

19 Section 25. The Governors State University Law is amended  
20 by adding Section 15-175 as follows:

22 Sec. 15-175. Search firm prohibition. Charges for the

1 services of an external hiring search firm may not be paid from  
2 any source of funds, except (i) in the hiring of the President  
3 of the University or (ii) in the case of when the President of

5 guidance from an individual or firm with specific expertise in  
6 the field of the hiring. The University shall implement a  
7 policy under this Section, including qualifying criteria,  
8 within 6 months after the effective date of this amendatory Act  
9 of the 97th General Assembly.

10 Section 30. The Illinois State University Law is amended by  
11 adding Section 20-180 as follows:

13 Sec. 20-180. Search firm prohibition. Charges for the  
14 services of an external hiring search firm may not be paid from  
15 any source of funds, except (i) in the hiring of the President  
16 of the University or (ii) in the case of when the President of  
17 the University and the Board demonstrate a justifiable need for  
18 guidance from an individual or firm with specific expertise in  
19 the field of the hiring. The University shall implement a  
20 policy under this Section, including qualifying criteria,  
21 within 6 months after the effective date of this amendatory Act  
22 of the 97th General Assembly.

23 Section 35. The Northeastern Illinois University Law is

1 amended by adding Section 25-175 as follows:

2 (110 ILCS 680/25-175 new)

3 Sec. 25-175. Search firm prohibition. Charges for the  
4 services of an external hiring search firm may not be paid from  
5 any source of funds, except (i) in the hiring of the President  
6 of the University or (ii) in the case of when the President of  
7 the University and the Board demonstrate a justifiable need for  
8 guidance from an individual or firm with specific expertise in  
9 the field of the hiring. The University shall implement a  
10 policy under this Section, including qualifying criteria,  
11 within 6 months after the effective date of this amendatory Act  
12 of the 97th General Assembly.

13 Section 40. The Northern Illinois University Law is amended  
14 by adding Section 30-185 as follows:

15 (110 ILCS 685/30-185 new)

16 Sec. 30-185. Search firm prohibition. Charges for the  
17 services of an external hiring search firm may not be paid from  
18 any source of funds, except (i) in the hiring of the President  
19 of the University or (ii) in the case of when the President of  
20 the University and the Board demonstrate a justifiable need for  
21 guidance from an individual or firm with specific expertise in  
22 the field of the hiring. The University shall implement a  
23 policy under this Section, including qualifying criteria,

1 within 6 months after the effective date of this amendatory Act  
2 of the 97th General Assembly.

3 Section 45. The Western Illinois University Law is amended  
4 by adding Section 35-180 as follows:

5 (110 ILCS 690/35-180 new)

6 Sec. 35-180. Search firm prohibition. Charges for the  
7 services of an external hiring search firm may not be paid from  
8 any source of funds, except (i) in the hiring of the President  
9 of the University or (ii) in the case of when the President of  
10 the University and the Board demonstrate a justifiable need for  
11 guidance from an individual or firm with specific expertise in  
12 the field of the hiring. The University shall implement a  
13 policy under this Section, including qualifying criteria,  
14 within 6 months after the effective date of this amendatory Act  
15 of the 97th General Assembly."
