2 AMENDMENT NO. _____. Amend House Bill 6040, by replacing
3 everything after the enacting clause with the following:

4 "ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated from the
8 Insurance Producer Administration Fund to the Department of

 18 may be necessary, is appropriated from the Insurance Producer
 19 Administration Fund to the Department of Insurance for costs
 20 and expenses related to or in support of the agency's
 21 operations.
