1 AMENDMENT TO SENATE BILL 1306

2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 1306 as follows:

3 on page 6, by replacing lines 19 through 23 with the following:

4 "(a) The Commission may adopt any rules and procedures  
5 necessary to enforce and administer the provisions of this  
6 Act."; and

7 on page 8, line 2, by replacing "\$5.50" with "\$10"; and

8 on page 8, by replacing lines 16 and 17 with the following:

9 "(a) It shall be unlawful for any person or entity to  
10 repossess"; and

11 on page 8, by replacing lines 22 and 23 with the following:

12 "(b) It shall be unlawful for any person to repossess a  
13 vehicle"; and

1 on page 9, by replacing lines 2 through 3 with the following:

2 "(c) It shall be unlawful for any person to repossess a  
3 vehicle"; and

4 on page 13, line 1, after "Commission.", by inserting the  
5 following:

6 "It shall be unlawful for any person or entity to repossess a  
7 vehicle or collateral in the State without a recovery ticket  
8 issued by the Commission."; and

9 on page 13, line 9, after "Act.", by inserting the following:

10 "State, county, and local municipalities shall work in  
11 conjunction with the Commission in the enforcement of this  
12 Act."; and

13 on page 21, by replacing lines 17 and 18 with the following:

14 "(a) The license and permit fees required under this Act  
15 are as follows."; and

16 on page 35, line 16, by deleting "No fee may be"; and

17 on page 35, by deleting lines 17 and 18; and

18 on page 35, by replacing lines 21 through 23 with the  
19 following:

20 "business of collateral recovery in a manner that is less

1 stringent than the standards established under this Act. To  
2 the"; and

3 on page 36, by replacing lines 1 through 2 with the following:  
4 "including a home rule unit, is less stringent than the  
5 standards established under this Act, it is superseded by this  
6 Act. This".

7 by replacing line 20 on page 41 through line 1 on page 42 with  
8 the following:

9 "recovery permit. The Commission may take any immediate  
10 disciplinary action that the Commission may deem proper if a  
11 person or entity repossesses a vehicle or collateral in the  
12 State without a valid license and permit. For all other  
13 disciplinary actions against a license or recovery permit  
14 holder, the Commission shall (i) notify the accused in writing  
15 of any charges made and the time and place for a hearing on the  
16 charges a least 30 days before the date set for the hearing,  
17 (ii) direct the accused to file a"; and

18 on page 49, by replacing lines 6 and 7 with the following:

19 "Section 999. Effective date. This Act takes effect on July  
20 1, 2012.".
