1 AMENDMENT TO SENATE BILL 1318

2 AMENDMENT NO. _____. Amend Senate Bill 1318 by replacing
3 line 4 on page 1 through line 11 on page 2 with the following:

4 "Section 5. The University of Illinois Act is amended by
5 changing Section 7f as follows:

6 (110 ILCS 305/7f) (from Ch. 144, par. 28f)

7 Sec. 7f. Partial tuition waivers.

8 (a) As used in this Section, "Illinois college or
9 university" means any of the following: the University of
10 Illinois, Southern Illinois University, Chicago State
11 University, Eastern Illinois University, Governors State
12 University, Illinois State University, Northeastern Illinois
13 University, Northern Illinois University, and Western Illinois
14 University.

15 (b) Each year the Board of Trustees of the University of
16 Illinois shall offer 50% tuition waivers for undergraduate

1 education at any campus under its governance or supervision to
2 the children of employees of an Illinois college or university
3 who have been employed by any one or by more than one Illinois
4 college or university for an aggregate period of at least 7
5 years. To be eligible to receive a partial tuition waiver, the
6 child of an employee of an Illinois college or university (i)
7 must be under the age of 25 at the commencement of the academic
8 year during which the partial tuition waiver is to be
9 effective, and (ii) must qualify for admission to the
10 University of Illinois under the same admissions requirements,
11 standards and policies which the University of Illinois applies
12 to applicants for admission generally to its respective
13 undergraduate colleges and programs.

14 (c) Subject to the provisions and limitations of subsection
15 (b), an eligible applicant who has continued to maintain
16 satisfactory academic progress toward graduation may have his
17 or her partial tuition waiver renewed until the time as he or
18 she has expended 4 years of undergraduate partial tuition
19 waiver benefits under this Section.

20 (d) No partial tuition waiver offered or allocated to any
21 eligible applicant in accordance with the provisions of this
22 Section shall be charged against any tuition waiver limitation
23 established by the Illinois Board of Higher Education.

24 (e) The Board of Trustees shall prescribe rules and
25 regulations as are necessary to implement and administer the
26 provisions of this Section.

1 (f) Beginning on the effective date of this amendatory Act
2 of the 97th General Assembly, this Section shall apply only to
3 children of employees of an Illinois college or university who
4 have been employed by any one or by more than one Illinois

14 Illinois, Southern Illinois University, Chicago State
15 University, Eastern Illinois University, Governors State
16 University, Illinois State University, Northeastern Illinois
17 University, Northern Illinois University, and Western Illinois
18 University.

19 (b) Each year the Board of Trustees of Southern Illinois
20 University shall offer 50% tuition waivers for undergraduate
21 education at any campus under its governance or supervision to
22 the children of employees of an Illinois college or university
23 who have been employed by any one or by more than one Illinois
24 college or university for an aggregate period of at least 7

1 years. To be eligible to receive a partial tuition waiver, the
2 child of an employee of an Illinois college or university (i)
3 must be under the age of 25 at the commencement of the academic
4 year during which the partial tuition waiver is to be
5 effective, and (ii) must qualify for admission to Southern
6 Illinois University under the same admissions requirements,
7 standards and policies which Southern Illinois University

16 offer 50% tuition waivers for undergraduate education at any
17 campus under its governance to the children of employees of an
18 Illinois college or university who have been employed by any
19 one or by more than one Illinois college or university for an
20 aggregate period of at least 7 years. To be eligible to receive
21 a partial tuition waiver, the child of an employee of an
22 Illinois college or university (i) must be under the age of 25
23 at the commencement of the academic year during which the
24 partial tuition waiver is to be effective, and (ii) must

1 qualify for admission to Chicago State University under the
2 same admissions requirements, standards and policies which
3 Chicago State University applies to applicants for admission
