1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

1 costs.

2 Section 99. Effective date. This Act takes effect July 1,  
3 2011.
