A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much  
6 thereof as may be necessary, respectively, are appropriated  
7 from the General Revenue Fund for the objects and purposes  
8 hereinafter named to meet the ordinary and contingent  
9 expenses of the State Employees' Retirement System:

10 SOCIAL SECURITY DIVISION

11	For Personal Services .....	49,900
12	For State Contributions to	
13	Social Security .....	3,900
14	For Contractual Services .....	19,600
15	For Travel .....	1,200
16	For Commodities .....	200

4 ARTICLE 2

5 Section 1. The sum of \$1,041,371,800, or so much thereof  
6 as may be necessary, is appropriated from the General Revenue  
7 Fund to the Board of Trustees of the State Employees'  
8 Retirement System of Illinois for the State's contribution,  
9 as provided by law.

10 Section 5. The sum of \$88,210,000, or so much thereof as  
11 may be necessary, is appropriated from the General Revenue  
12 Fund to the Board of Trustees of the Judges' Retirement  
13 System of Illinois for the State's contribution, as provided  
14 by law.

15 Section 10. The sum of \$14,150,000, or so much thereof  
16 as may be necessary, is appropriated from the General Revenue  
17 Fund to the Board of Trustees of the General Assembly  
18 Retirement System for the State's contribution, as provided  
19 by law.

20 Section 99. Effective date. This Act takes effect July 1,
