### SYNOPSIS AS INTRODUCED:

10 ILCS 5/1A-17 110 ILCS 205/20 new

Amends the Election Code. Provides that, for each even-numbered year that a general election is to be held, each public institution of higher learning shall send an electronic message to each student enrolled in the institution devoted exclusively to information on voter registration. Sets forth requirements concerning the content of the message and when it should be sent. Provides that the Board of Higher Education shall issue a notice to each public institution of higher learning of the requirements concerning the electronic message in August of each even-numbered year during which a general election is held. Amends the Board of Higher Education Act. Provides that the Board of Higher Education shall include specified information concerning college voter registration on its Internet website. Effective January 1, 2014.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Election Code is amended by changing Section
1A-17 as follows:

6 (10 ILCS 5/1A-17)

7 Sec. 1A-17. Voter registration outreach.

8 (a) The Secretary of State, the Department of Human 9 Services, the Department of Children and Family Services, the Department of Public Aid, the Department of Employment 10 Security, and each public institution of higher learning in 11 Illinois must make available on its World Wide Web site a 12 13 downloadable, printable voter registration form that complies 14 with the requirements in subsection (d) of Section 1A-16 for the State Board of Elections' voter registration form. 15

(b) Each public institution of higher learning in Illinois 16 17 must include voter registration information and a voter registration form supplied by the State Board of Elections 18 19 under subsection (e) of Section 1A-16 in any mailing of student registration materials to an address located in Illinois. Each 20 21 public institution of higher learning must provide voter 22 registration information and a voter registration form supplied by the State Board of Elections under subsection (e) 23

1 of Section 1A-16 to each person with whom the institution 2 conducts in-person student registration.

3 (c) As used in this Section, a public institution of higher
4 learning means a public university, college, or community
5 college in Illinois.

6 (d) In addition to any other requirements of this Section, 7 each public institution of higher learning shall send an 8 electronic message devoted exclusively to information on voter 9 registration to each student enrolled in the institution at an e-mail address provided by the student. This electronic message 10 11 shall include a link to the websites for the local election 12 authority and the State Board of Elections, and a downloadable 13 voter registration application. The electronic message shall 14 contain information on grace period voter registration. This electronic message shall be sent between September 15 and 15 16 September 25 of each even-numbered year during which a general 17 election is held. Each public institution of higher learning shall submit a copy of their electronic message, along with the 18 19 date that it was sent, to the Board of Higher Education.

20 <u>(e) The Board of Higher Education shall maintain on its</u> 21 <u>Internet website a page devoted to the ongoing compliance with</u> 22 <u>subsection (d) of this Section. The page shall contain: (i) a</u> 23 <u>list of all public institutions of higher learning; (ii) a link</u> 24 <u>to the page on each institution's website that contains</u> 25 <u>information on voter registration; (iii) suggested language</u> 26 <u>for the electronic message that each institution must send; and</u>
