#### SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.826 new  
625 ILCS 5/3-699 new

Amends the Illinois Vehicle Code. Provides for the issuance of National Wild Turkey Federation license plates. Provides that in addition to the appropriate registration fees, an applicant for the special plate shall be charged a fee of \$15 at original issuance and \$2 at renewal, which shall be deposited into the Secretary of State Special License Plate Fund. Amends the State Finance Act to make corresponding changes.

A BILL FOR

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The State Finance Act is amended by adding  
5 Section 5.826 as follows:

6 (30 ILCS 105/5.826 new)

7 Sec. 5.826. The National Wild Turkey Federation Fund.

8 Section 10. The Illinois Vehicle Code is amended by adding  
9 Section 3-699 as follows:

10 (625 ILCS 5/3-699 new)

11 Sec. 3-699. National Wild Turkey Federation license  
12 plates.

13 (a) The Secretary, upon receipt of all applicable fees and  
14 applications made in the form prescribed by the Secretary, may  
15 issue special registration plates designated as National Wild  
16 Turkey Federation license plates. The special plates issued  
17 under this Section shall be affixed only to passenger vehicles  
18 of the first division or motor vehicles of the second division  
19 weighing not more than 8,000 pounds. Plates issued under this  
20 Section shall expire according to the multi-year procedure  
21 established by Section 3-414.1 of this Code.

1       (b) The design and color of the special plates shall be  
2 wholly within the discretion of the Secretary. The Secretary  
3 may allow the plates to be issued as vanity plates or  
4 personalized plates under Section 3-405.1 of this Code. The  
5 Secretary shall prescribe stickers or decals as provided under  
6 Section 3-412 of this Code.

7       (c) An applicant for the special plate shall be charged a  
8 \$40 fee for original issuance in addition to the appropriate  
9 registration fee. Of this fee, \$25 shall be deposited into the  
10 National Wild Turkey Federation Fund and \$15 shall be deposited  
11 into the Secretary of State Special License Plate Fund, to be  
12 used by the Secretary to help defray the administrative  
13 processing costs.

14       For each registration renewal period, a \$27 fee, in  
15 addition to the appropriate registration fee, shall be charged.  
16 Of this fee, \$25 shall be deposited into the National Wild  
17 Turkey Federation Fund and \$2 shall be deposited into the  
18 Secretary of State Special License Plate Fund.

19       (d) The National Wild Turkey Federation Fund is created as  
20 a special fund in the State treasury. All moneys in the  
21 National Wild Turkey Federation Fund shall be paid, subject to  
22 appropriation by the General Assembly and distribution by the  
23 Secretary, as grants to National Wild Turkey Federation, Inc.,  
24 a tax exempt entity under Section 501(c)(3) of the Internal  
25 Revenue Code, to fund turkey habitat protection, enhancement,  
26 and restoration projects in the State of Illinois, to fund

1 education and outreach for media, volunteers, members, and the  
2 general public regarding turkeys and turkey habitat  
3 conservation in the State of Illinois, and to cover the  
4 reasonable cost for National Wild Turkey Federation special  
5 plate advertising and administration of the conservation  
6 projects and education program.
