A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated from the  
8 General Revenue Fund to the Department of Veterans' Affairs:

21 Section 15. The amount of \$0, or so much thereof as may  
 22 be necessary, is appropriated from the General Revenue Fund  
 23 to the Department of Veterans' Affairs for costs associated

1 with a Post-Traumatic Stress Disorder Outpatient Counseling  
2 Program.

3 Section 20. The amount of \$250,000, or so much thereof  
4 as may be necessary, is appropriated from the Illinois  
5 Military Family Relief Fund to the Department of Veterans'  
6 Affairs for the payment of benefits authorized under the  
7 Survivor's Compensation Act.

8 Section 25. The amount of \$150,000, or so much thereof  
9 as may be necessary, is appropriated from the Illinois  
10 Veterans' Homes Fund to the Department of Veterans' Affairs  
11 to enhance the operations of veterans' homes in Illinois.

12 Section 30. The amount of \$0, or so much thereof as may  
13 be necessary, is appropriated from the Disabled Veterans  
14 Property Tax Relief Fund to the Department of Veterans'  
15 Affairs for the purpose of providing property tax relief to  
16 disabled veterans.

17 Section 35. The amount of \$8,300,000, or so much thereof  
18 as may be necessary, is appropriated from the Illinois  
19 Veterans Assistance Fund to the Department of Veterans'  
20 Affairs for making grants, funding additional services, or  
21 conducting additional research projects relating to veterans'

1 post traumatic stress disorder; veterans' homelessness; the  
 2 health insurance cost of veterans; veterans' disability  
 3 benefits, including but not limited to, disability benefits  
 4 provided by veterans service organizations and veterans  
 5 assistance commissions or centers; and the long-term care of  
 6 veterans.

7 Section 40. The amount of \$297,000, or so much thereof  
 8 as may be necessary, is appropriated from the General Revenue  
 9 Fund to the Department of Veterans' Affairs for costs  
 10 associated with the Illinois Warrior Assistance Program.

11 Section 45. The following named amounts, or so much  
 12 thereof as may be necessary, respectively, are appropriated  
 13 to the Department of Veterans' Affairs for objects and  
 14 purposes hereinafter named:
