SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.855 new
625 ILCS 5/3-699.14 new

Amends the State Finance Act. Creates the Lupus Foundation of America Fund. Amends the Illinois Vehicle Code. Provides that the Secretary of State may issue Lupus Foundation of America plates. Provides that the cost of initial issuance of these plates shall be \$20 in addition to any other fees, \$5 of which will go to the Lupus Foundation of America Fund and \$15 of which will go to the Secretary of State Special License Plate Fund. Provides that renewal of these plates will cost \$20, \$18 of which will go to the Lupus Foundation of America Fund and \$2 of which will go to the Secretary of State Special License Plate Fund. Allows for distribution, subject to appropriation, of money from the Lupus Foundation of America Fund to the Lupus Foundation of America, Illinois Chapter.

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The State Finance Act is amended by adding
5 Section 5.855 as follows:

6 (30 ILCS 105/5.855 new)

7 Sec. 5.855. The Lupus Foundation of America Fund.

8 Section 10. The Illinois Vehicle Code is amended by adding
9 Section 3-699.14 as follows:

10 (625 ILCS 5/3-699.14 new)

11 Sec. 3-699.14. Lupus Foundation of America plates.

12 (a) The Secretary, upon receipt of all applicable fees and
13 applications made in the form prescribed by the Secretary, may
14 issue special registration plates designated as Lupus
15 Foundation of America license plates.

16 The special plates issued under this Section shall be
17 affixed only to passenger vehicles of the first division or
18 motor vehicles of the second division weighing not more than
19 8,000 pounds.

20 Plates issued under this Section shall expire according to
21 the multi-year procedure established by Section 3-414.1 of this

1 Code.

2 (b) The design and color of the special plates shall be
3 wholly within the discretion of the Secretary. Appropriate
4 documentation, as determined by the Secretary, shall accompany
5 each application.

6 (c) An applicant for the special plate shall be charged a
7 \$20 fee for original issuance in addition to the appropriate
8 registration fee. Of this fee, \$5 shall be deposited into the
9 Lupus Foundation of America Fund and \$15 shall be deposited
10 into the Secretary of State Special License Plate Fund, to be
11 used by the Secretary to help defray the administrative
12 processing costs.

13 For each registration renewal period, a \$20 fee, in
14 addition to the appropriate registration fee, shall be charged.
15 Of this fee, \$18 shall be deposited into the Lupus Foundation
16 of America Fund and \$2 shall be deposited into the Secretary of
17 State Special License Plate Fund.

18 (d) The Lupus Foundation of America Fund is created as a
19 special fund in the State treasury. All money in the Lupus
20 Foundation of America Fund shall be paid, subject to
21 appropriation by the General Assembly and distribution by the
22 Secretary, as grants to the Lupus Foundation of America,
23 Illinois Chapter.
