A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated from the

9 health insurance cost of veterans; veterans' disability
10 benefits, including but not limited to, disability benefits
11 provided by veterans service organizations and veterans
12 assistance commissions or centers; and the long-term care of
13 veterans.

14 Section 25. The amount of \$194,900, or so much thereof
