### SYNOPSIS AS INTRODUCED:

Amends "An Act making appropriations", Public Act 98-27, "An Act making appropriations", Public Act 98-50, and "An Act making appropriations", Public Act 98-64. Appropriates certain sums to the Department of Human Services, the Department of Human Rights, the Department of Public Health, the Department of Corrections, the Department of Juvenile Justice, and the Department of Natural Resources for personal services and State contributions to Social Security. Appropriates a certain sum to the State Comptroller for deposit into the Backlog Payment Fund. Effective immediately.

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. "An Act making appropriations", Public Act  
5 98-27, approved June 21, 2013, is amended by adding Section  
6 33 to Article 8, by adding Section 13 to Article 9, and by  
7 adding Section 7 to Article 10 as follows:

8 (P.A. 98-27, Article 8, Section 33 new)

9 Sec. 33. In addition to any amount heretofore  
10 appropriated, the sum of \$30,000, or so much thereof as may  
11 be necessary, is appropriated to the Department of Human  
12 Rights for Personal Services and State Contributions to  
13 Social Security, including prior year costs, at the  
14 approximate costs below:

15 For Personal Services .....\$21,000

16 For State Contributions to Social Security .....\$9,000

17 (P.A. 98-27, Article 9, Section 13 new)

18 Sec. 13. In addition to any amount heretofore  
19 appropriated, the sum of \$21,006,800, or so much thereof as  
20 may be necessary, is appropriated to the Department of Human  
21 Services for Personal Services and State Contributions to

1 Social Security, including prior year costs, at the  
2 approximate costs below:

3 For Personal Services .....\$19,513,900

4 For State Contributions to Social Security .....\$1,492,900

5 (P.A. 98-27, Article 10, Section 7 new)

6 Sec. 7. In addition to any amount heretofore  
7 appropriated, the sum of \$1,753,300, or so much thereof as  
8 may be necessary, is appropriated to the Department of Public  
9 Health for Personal Services and State Contributions to  
10 Social Security, including prior year costs, at the  
11 approximate costs below:

12 For Personal Services .....\$1,628,700

13 For State Contributions to Social Security .....\$124,600

14 Section 10. "An Act making appropriations", Public Act 98-  
15 50, approved with items vetoed by the Governor on July 2,  
16 2013, is amended by adding Section 7 to Article 4 and by  
17 adding Section 7 to Article 11 as follows:

18 (P.A. 98-50, Article 4, Section 7 new)

19 Sec. 7. In addition to any amount heretofore  
20 appropriated, the sum of \$82,845,100, or so much thereof as  
21 may be necessary, is appropriated to the Department of  
22 Corrections for Personal Services and State Contributions to

1 Social Security, including prior year costs, at the  
2 approximate costs below:

3 For Personal Services .....\$76,957,800  
4 For State Contributions to Social Security .....\$5,887,300

5 (P.A. 98-50, Article 11, Section 7 new)

6 Sec. 7. In addition to any amount heretofore  
7 appropriated, the sum of \$5,619,000, or so much thereof as  
8 may be necessary, is appropriated to the Department of  
9 Juvenile Justice for Personal Services and State  
10 Contributions to Social Security, including prior year costs,  
11 at the approximate costs below:

12 For Personal Services .....\$5,219,700  
13 For State Contributions to Social Security .....\$399,300

14 Section 15. "An Act making appropriations", Public Act 98-  
15 64, approved with items vetoed by the Governor on July 10,  
16 2013, is amended by adding Section 35 to Article 9 and  
17 Section 3 to Article 31 as follows:

18 (P.A. 98-64, Article 9, Section 35 new)

19 Sec. 35. The sum of \$1,100,000,000, or so much thereof as  
20 may be necessary, is appropriated from the General Revenue  
21 Fund to the Office of the State Comptroller for deposit into  
22 the Backlog Payment Fund.

1 (P.A. 98-64, Article 31, Section 3 new)

2 Sec. 3. In addition to any amount heretofore  
3 appropriated, the sum of \$1,000,100, or so much thereof as  
4 may be necessary, is appropriated to the Department of  
5 Natural Resources for Personal Services and State  
6 Contributions to Social Security, including prior year costs,  
7 at the approximate costs below:

8 For Personal Services .....\$929,000  
9 For State Contributions to Social Security .....\$71,100

10 Section 99. Effective date. This Act takes effect upon  
11 becoming law.
