2 AMENDMENT NO. _____. Amend Senate Bill 20 as follows:

3 on page 9, line 9, by replacing ", and (iv)" with ", (iv)"; and

4 on page 9, lines 15 and 16, by replacing ", or Plant Operating
5 Engineer" with ", Plant Operating Engineer, Civil Engineer V,
6 Civil Engineer VI, Civil Engineer VII, Technical Manager I,
7 Technical Manager II, Technical Manager III, Technical Manager
8 IV, Technical Manager V, Technical Manager VI, Realty
9 Specialist III, Realty Specialist IV, Realty Specialist V,
10 Technical Advisor I, Technical Advisor II, Technical Advisor
11 III, Technical Advisor IV, or Technical Advisor V, and (v)
12 beginning on the effective date of this amendatory Act of the
13 98th General Assembly and notwithstanding any other provision
14 of this Act, any mental health administrator in the Department
15 of Corrections who is classified as or who holds the position
16 of Public Service Administrator (Option 8K), any attorney in

1 the Department of Corrections who is classified as or who holds
2 the position of Public Service Administrator (Option 8L), any
3 nuclear safety staff attorney in the Illinois Emergency
4 Management Agency, any Section Chief, Deputy Lab Director,
5 Research and Development Coordinator, Quality Assurance
6 Director, or Assistant Director of Training in the Department
7 of State Police who is classified as or who holds the position
8 of Senior Public Service Administrator (Option 7), any employee
9 of the Office of the Inspector General in the Department of
10 Human Services who is classified as or who holds the position
11 of Public Service Administrator (Option 7), any Deputy of
12 Intelligence in the Department of Corrections who is classified
13 as or who holds the position of Public Service Administrator
14 (Option 7), and any employee of the Department of State Police
15 who handles issues concerning the Illinois State Police Sex
16 Offender Registry and who is classified as or holds the
17 position of Public Service Administrator (Option 7)"; and

18 on page 21, line 7, by replacing "subsection (e)" with
19 "subsections (e) and (f)"; and

20 on page 24, line 13, by replacing ", or Plant Operating
21 Engineer." with the following:

22 ", Plant Operating Engineer, Civil Engineer V, Civil Engineer
23 VI, Civil Engineer VII, Technical Manager I, Technical Manager
24 II, Technical Manager III, Technical Manager IV, Technical

5 (f) The provisions of this Section also do not apply to any
6 mental health administrator in the Department of Corrections
7 who is classified as or who holds the position of Public
8 Service Administrator (Option 8K), any attorney in the
9 Department of Corrections who is classified as or who holds the
10 position of Public Service Administrator (Option 8L), any
11 nuclear safety staff attorney in the Illinois Emergency
12 Management Agency, any Section Chief, Deputy Lab Director,
13 Research and Development Coordinator, Quality Assurance
14 Director, or Assistant Director of Training in the Department
15 of State Police who is classified as or who holds the position
16 of Senior Public Service Administrator (Option 7), any employee
17 of the Office of the Inspector General in the Department of
18 Human Services who is classified as or who holds the position
19 of Public Service Administrator (Option 7), any Deputy of
20 Intelligence in the Department of Corrections who is classified
21 as or who holds the position of Public Service Administrator
22 (Option 7), or any employee of the Department of State Police
23 who handles issues concerning the Illinois State Police Sex
24 Offender Registry and who is classified as or holds the
25 position of Public Service Administrator (Option 7)."
