- 1 (c) Applications, related documents, and medical records received by the Experimental Organ Transplantation Procedures 2 Board and any and all documents or other records prepared by 3 4 the Experimental Organ Transplantation Procedures Board or its 5 staff relating to applications it has received.
  - (d) Information and records held by the Department of Public Health and its authorized representatives relating to known or suspected cases of sexually transmissible disease or any information the disclosure of which is restricted under the Illinois Sexually Transmissible Disease Control Act.
  - (e) Information the disclosure of which is exempted under Section 30 of the Radon Industry Licensing Act.
  - (f) Firm performance evaluations under Section 55 of the Architectural, Engineering, and Land Surveying Qualifications Based Selection Act.
  - (q) Information the disclosure of which is restricted and exempted under Section 50 of the Illinois Prepaid Tuition Act.
    - (h) Information the disclosure of which is exempted under the State Officials and Employees Ethics Act, and records of any lawfully created State or local inspector general's office that would be exempt if created or obtained by an Executive Inspector General's office under that Act.
- (i) Information contained in a local emergency energy plan submitted to a municipality in accordance with a local emergency energy plan ordinance that is adopted under Section 26 11-21.5-5 of the Illinois Municipal Code.

- 1 (j) Information and data concerning the distribution of surcharge moneys collected and remitted by wireless carriers 2 3 under the Wireless Emergency Telephone Safety Act.
  - (k) Law enforcement officer identification information or driver identification information compiled by enforcement agency or the Department of Transportation under Section 11-212 of the Illinois Vehicle Code.
  - (1) Records and information provided to a residential health care facility resident sexual assault and death review team or the Executive Council under the Abuse Prevention Review Team Act.
