

98TH GENERAL ASSEMBLY State of Illinois 2013 and 2014 SB1673

Introduced 2/13/2013, by Sen. Matt Murphy

SYNOPSIS AS INTRODUCED:

10 ILCS 5/9-8.7 new 20 ILCS 3005/9.3 new

Amends the Election Code. Prohibits campaign contributions to General Assembly members from recipients of their legislative member initiatives for 5 years after initial disbursement of moneys. Amends the Governor's Office of Management and Budget Act. Requires GOMB to establish a single updated searchable database website accessible by the public at no cost that includes information concerning each entity that receives Illinois funding. Requires GOMB to report to the General Assembly concerning the website. Effective immediately.

- 4 Section 5. The Election Code is amended by adding Section
- 9-8.7 as follows:
- 6 (10 ILCS 5/9-8.7 new)
- 7 Sec. 9-8.7. Prohibited contributions.
- 8 (a) For the purposes of this Section, "legislative member
- 9 initiative" is defined as provided in Section 9.3 of the
- 10 Governor's Office of Management and Budget Act.
- 11 (b) A political committee organized by or on behalf of a
- 12 State Senator or State Representative may not accept a
- 13 contribution from the recipient of that Senator's or
- Representative's legislative member initiative for 5 years
- beginning on the date of first disbursement of moneys under
- that initiative to that recipient.
- 17 (c) A contribution accepted in violation of this Section
- 18 shall escheat to the State and be deposited into the State
- 19 treasury.

| 15 | a grant or distribution to a specific unit of local |

| 17 | not-for-profit organization, or specific non-governmental |
| 18 | entity for infrastructure improvements or operating |
| 19 | expenses. Appropriations that are part of a statewide |
| 20 | program and are based on generally applicable standards of |
| 21 | eligibility are not legislative member initiatives. |

| 22 | searched electronically by field in a single search; |
| 23 | (2) shall provide an opportunity for the public to |

| 26 | (3) shall be updated not later than 30 days after the |

- 2 (d) GOMB responsibilities. The Director of GOMB shall
- 3 provide guidance to agency heads to ensure compliance with this
- 4 Section.
- 5 (e) Report. By March 1 of each year, the Director of GOMB
- 6 shall report to the General Assembly on implementation and
- 7 operation of the website, which shall include data about the
- 8 usage and public feedback on the utility of the site, including
- 9 recommendations for improvements. The annual report shall be
- made publicly available on the website.
- 11 Section 99. Effective date. This Act takes effect upon
- 12 becoming law.
