1 Education, in cooperation with one or more not-for-profit organizations in the State that support excellence in teaching, 2 which may be in partnership with a university that offers 3 4 4-year baccalaureate and masters degree programs and that is a 5 recognized institution as defined in Section 21B-105 of this 6 Code, may within 30 days after submission by the program sponsor approve a course of study developed by the program 7 8 sponsor that persons in the program must successfully complete 9 in order to satisfy one criterion for issuance of an 10 alternative certificate under this Section. The Alternative 11 Teacher Certification program course of study must include content and skills which have been approved by the State Board 12 13 Education, in consultation with the State Teacher of 14 Certification Board, as meeting the requirement for State 15 teacher certification.

16 The alternative certification program established under this Section shall be known as the Alternative Teacher 17 Certification program. The Alternative Teacher Certification 18 19 Program shall be offered by the submitting partnership, and 20 such partnership may be offered by one or more not-for-profit 21 organizations in the State which support excellence in 22 teaching. The program shall be comprised of the following 3 23 phases: (a) the first phase is the course of study offered on 24 an intensive basis in education theory, instructional methods, 25 and practice teaching; (b) the second phase is the person's 26 assignment to a full-time teaching position for one school 09800SB1845ham001 -3- LRB098 09595 RPM 49229 a

1 year; and (c) the third phase is a comprehensive assessment of the person's teaching performance by school officials and the 2 3 partnership participants and a recommendation by the program 4 sponsor to the State Board of Education that the person be 5 issued a standard alternative teaching certificate. Successful completion of the Alternative Teacher Certification program 6 shall be deemed to satisfy any other practice or student 7 8 teaching and subject matter requirements established by law.

9 A provisional alternative teaching certificate, valid for 10 one year of teaching in the common schools and not renewable, 11 shall be issued under this Section 21-5b to persons who at the 12 time of applying for the provisional alternative teaching 13 certificate under this Section:

14 (1) have graduated from an accredited college or15 university with a bachelor's degree;

16 (2) have successfully completed the first phase of the 17 Alternative Teacher Certification program as provided in 18 this Section;

19 (3) have passed the tests of basic skills and subject
 20 matter knowledge required by Section 21-1a; and

(4) (i) have been employed for a period of at least 5 years in an area requiring application of the individual's education or (ii) have attained at least a cumulative grade average of a "B" if the individual is assigned either to a school district that has not met the annual measurable objective for highly qualified teachers required by the

1 Illinois Revised Highly Qualified Teachers (HQT) Plan or to a school district whose data filed with the State Board of 2 3 Education indicates that the district's poor and minority 4 students are taught by teachers who are not highly 5 qualified at a higher rate than other students; however, this item (4) does not apply with respect to a provisional 6 alternative teaching certificate for teaching in schools 7 8 situated in a school district that is located in a city 9 having a population in excess of 500,000 inhabitants. 10 Assignment may be made under clause (ii) of this item (4) 11 only if the district superintendent and the exclusive bargaining representative of the district's teachers, if 12 13 any, jointly agree to permit the assignment.

A person possessing a provisional alternative certificate under this Section shall be treated as a regularly certified teacher for purposes of compensation, benefits, and other terms and conditions of employment afforded teachers in the school who are members of a bargaining unit represented by an exclusive bargaining representative, if any.

20 Until February 15, 2000, a standard alternative teaching 21 certificate, valid for 4 years for teaching in the schools and 22 renewable as provided in Section 21-14, shall be issued under 23 Section 21-5b to persons who first complete this the 24 requirements for the provisional alternative teaching 25 certificate and who at the time of applying for a standard 26 alternative teaching certificate under this Section have

1 successfully completed the second and third phases of the 2 Alternative Teacher Certification program as provided in this Section. Alternatively, beginning February 15, 2000, at the end 3 4 of the 4-year validity period, persons who were issued a 5 standard alternative teaching certificate shall be eligible, 6 on the same basis as holders of an Initial Teaching Certificate issued under subsection (b) of Section 21-2 of this Code, to 7 apply for a Standard Teaching Certificate, provided they meet 8 9 the requirements of subsection (c) of Section 21-2 of this Code 10 and further provided that a person who does not apply for and 11 receive a Standard Teaching Certificate shall be able to teach only in schools situated in a school district that is located 12 13 in a city having a population in excess of 500,000 inhabitants.

14 Beginning February 15, 2000, persons who have completed the 15 requirements for a standard alternative teaching certificate 16 under this Section shall be issued an Initial Alternative Teaching Certificate valid for 4 years of teaching and not 17 renewable. At the end of the 4-year validity period, these 18 19 persons shall be eligible, on the same basis as holders of an 20 Initial Teaching Certificate issued under subsection (b) of 21 Section 21-2 of this Code, to apply for a Standard Teaching 22 Certificate, provided they meet the requirements of subsection 23 (c) of Section 21-2.

1 commencement of the 1997-1998 academic year and the first 2 standard alternative teaching certificates issued under this 3 Section are effective upon the commencement of the 1998-1999 4 academic year.

5 The State Board of Education, in cooperation with the 6 partnership or partnerships establishing such Alternative 7 Teacher Certification programs, shall adopt rules and 8 regulations that are consistent with this Section and that the 9 State Board of Education deems necessary to establish and 10 implement the program.

11 No one may be admitted to an alternative certification program under this Section after September 1, 2014 2013, and 12 13 those alternative certification candidates who are admitted on 14 or before September 1, 2014 <del>2013</del> must complete their coursework 15 the program before January 1, 2016 2015, except that candidates 16 admitted to an alternative certification program at Governors 17 State University and participants in the Teacher Quality 18 Partnership Grant program must be admitted on or before March 31, 2014, complete their coursework on or before August 31, 19 20  $\frac{2015_{r}}{r}$  and be entitled to certification on or before September 30, 2016 September 31, 2015. An The alternative certification 21 22 program at Governors State University shall provide the State 23 Board of Education with the names of the candidates who will be 24 eligible for certification under this exception.

4 Sec. 21-5c. Alternative route to teacher certification. 5 The State Board of Education, in consultation with the State Teacher Certification Board, shall establish and implement one 6 7 or more alternative route to teacher certification programs 8 under which persons who meet the requirements of and 9 successfully complete the programs established by this Section 10 shall be issued an initial teaching certificate for teaching in schools in this State. The State Board of Education may approve 11 12 a course of study that persons in such programs must 13 successfully complete in order to satisfy one criterion for 14 issuance of a certificate under this Section. The Alternative 15 Route to Teacher Certification programs course of study must include content and skills which have been approved by the 16 17 State Board of Education, in consultation with the State Teacher Certification Board, as meeting the requirement for 18 19 State teacher certification.

20 Programs established under this Section shall be known as 21 Alternative Route to Teacher Certification programs. The 22 programs may be offered by a university that offers 4-year 23 baccalaureate and masters degree programs and that is a 24 recognized institution as defined in Section 21B-105 of this 25 Code, by one or more not-for-profit organizations in the State, 09800SB1845ham001 -8- LRB098 09595 RPM 49229 a

1 or a combination thereof. The programs shall be comprised of the following 3 phases: (a) a course of study offered on an 2 intensive basis in education theory, instructional methods, 3 4 and practice teaching; (b) the person's assignment to a 5 full-time teaching position for one school year, including the designation of a mentor teacher to advise and assist the person 6 with that teaching assignment; and 7 (c) a comprehensive 8 assessment of the person's teaching performance by school 9 officials and program participants and a recommendation by the 10 program sponsor to the State Board of Education that the person 11 initial teaching certificate. Successful be issued an completion of Alternative Route to Teacher Certification 12 13 programs shall be deemed to satisfy any other practice or 14 student teaching and subject matter requirements established 15 by law.

A provisional alternative teaching certificate, valid for one year of teaching in the common schools and not renewable, shall be issued under this Section 21-5c to persons who at the time of applying for the provisional alternative teaching certificate under this Section:

An initial teaching certificate, valid for teaching in the common schools, shall be issued under Section 21-3 or 21-5 to persons who first complete the requirements for the provisional alternative teaching certificate and who at the time of applying for an initial teaching certificate have successfully completed the second and third phases of the Alternative Route to Teacher Certification program as provided in this Section.

A person possessing a provisional alternative certificate or an initial teaching certificate earned under this Section shall be treated as a regularly certified teacher for purposes of compensation, benefits, and other terms and conditions of employment afforded teachers in the school who are members of a bargaining unit represented by an exclusive bargaining representative, if any.

19 The State Board of Education may adopt rules and 20 regulations that are consistent with this Section and that the 21 State Board deems necessary to establish and implement the 22 program.

No one may be admitted to an alternative certification program under this Section after September 1, <u>2014</u> <del>2013</del>, and those <u>alternative certification</u> candidates who are admitted on or before <u>June 30, 2014</u> <del>September 1, 2013</del> must complete <u>their</u> 09800SB1845ham001 -10- LRB098 09595 RPM 49229 a

1 coursework the program before January 1, 2016 2015, except that 2 candidates admitted to an alternative certification program at Governors State University and participants in the Teacher 3 4 Quality Partnership Grant program must be admitted on or before 5 March 31, 2014, complete their coursework on or before August  $\frac{31}{2015}$  and be entitled to certification on or before 6 September 30, 2016 September 31, 2015.
