### SYNOPSIS AS INTRODUCED:

Makes appropriations to the University of Illinois for various purposes, including for ordinary and contingent expenses. Effective July 1, 2013.

A BILL FOR

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much  
5 thereof as may be necessary, respectively, for the objects  
6 and purposes hereinafter named, are appropriated to the Board  
7 of the Trustees of the University of Illinois to meet  
8 ordinary and contingent expenses for the fiscal year ending  
9 June 30, 2014:

10 Payable from the Education Assistance Fund:

11 For Personal Services, including payment  
12 to the university for personal services  
13 costs incurred during the fiscal year  
14 and salaries accrued but unpaid to academic  
15 personnel for personal services rendered  
16 during the 2013-2014 academic year .....\$521,317,900

17 For State Contributions to Social  
18 Security, for Medicare .....9,737,100

19 For Group Insurance .....24,893,200

20 For Contractual Services .....37,000,000

21 For distributive purposes as follows:

22 For Awards and Grants .....6,057,500

23 Total \$599,005,700

1           Section 10. The amount of \$45,000,000, or so much of that  
2 amount as may be necessary, is appropriated from the General  
3 Revenue Fund to the Board of Trustees of the University of  
4 Illinois for operating costs and expenses related to or in  
5 support of the University of Illinois Hospital.

6           Section 15. The amount of \$15,826,500, or so much of that  
7 amount as may be necessary, is appropriated from the General  
8 Revenue Fund to the Board of the Trustees of the University  
9 of Illinois for operating costs and expenses related to or in  
10 support of the Prairie Research Institute, in accordance with  
11 Public Act 95-728.

12           Section 20. The amount of \$750,900, or so much of that  
13 amount as may be necessary, is appropriated from the  
14 Education Assistance Fund to the Board of Trustees of the  
15 University of Illinois for costs associated with the Hispanic  
16 Center for Excellence at the Chicago campus.

17           Section 25. The amount of \$308,200, or so much of that  
18 amount as may be necessary, is appropriated from the  
19 Education Assistance Fund to the Board of Trustees of the  
20 University of Illinois for Dixon Springs Agricultural Center.

1 Section 30. The amount of \$1,173,200, or so much of that  
2 amount as may be necessary, is appropriated from the  
3 Education Assistance Fund to the Board of Trustees of the  
4 University of Illinois for costs associated with the Public  
5 Policy Institute at the Chicago campus.

6 Section 35. The amount of \$328,500, or so much of that  
7 amount as may be necessary, is appropriated from the  
8 Education Assistance Fund to the Board of Trustees of the  
9 University of Illinois for costs associated with the College  
10 of Dentistry.

11  
12 Section 40. The amount of \$3,523,700, or so much of that  
13 amount as may be necessary, is appropriated from the Fire  
14 Prevention Fund to the Board of Trustees of the University of  
15 Illinois for the purpose of maintaining the Illinois Fire  
16 Service Institute, paying the Institute's expenses, and  
17 providing the facilities and structures incident thereto,  
18 including payment to the University for personal services and  
19 related costs incurred.

21 Section 45. The amount of \$250,000, or so much of that  
22 amount as may be necessary, is appropriated from the State  
23 College and University Trust Fund to the Board of Trustees of  
24 the University of Illinois for scholarship grant awards, in

1 accordance with Public Act 91-83.

2 Section 50. The amount of \$200,000, or so much of that  
3 amount as may be necessary, is appropriated from the  
4 Emergency Public Health Fund to the University of Illinois  
5 for costs and expenses related to or in support of emergency  
6 mosquito abatement.

7 Section 55. The amount of \$200,000, or so much of that  
8 amount as may be necessary, is appropriated from the Used  
9 Tire Management Fund to the University of Illinois for costs  
10 and expenses related to or in support of mosquito research  
11 and abatement.

12 Section 60. The amount of \$500,000, or so much of that  
13 amount as may be necessary, is appropriated from the  
14 Hazardous Waste Research Fund to the University of Illinois  
15 for its ordinary and contingent expenses.

16 Section 65. The amount of \$500,000, or so much of that  
17 amount as may be necessary, is appropriated from the General  
18 Professions Dedicated Fund to the Board of Trustees of the  
19 University of Illinois for costs associated with the  
20 development, support, or administration of pharmacy practice  
21 education or training programs for the College of Medicine at

1 Rockford.

2 Section 99. Effective date. This Act takes effect July 1,  
3 2013.
