A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Criminal
9 Justice Information Authority:

4 Section 5. The sum of \$7,000,000, or so much thereof as
5 may be necessary, is appropriated from the General Revenue
6 Fund to the Illinois Criminal Justice Information Authority
7 for administrative costs, awards and grants for the Adult
8 Redeploy program.

9 Section 10. The sum of \$47,000,000, or so much thereof
10 as may be necessary, is appropriated from the Criminal
11 Justice Trust Fund to the Illinois Criminal Justice
12 Information Authority for awards and grants to local units of
13 government and non-profit organizations.

14 Section 15. The additional sum of \$16,700,000, or so
15 much thereof as may be necessary, is appropriated from the
16 Criminal Justice Trust Fund to the Illinois Criminal Justice
17 Information Authority for Byrne/JAG awards and grants to
18 local units of government and non-profit organizations in
19 accordance with applicable laws and regulations for the State
20 portion of federal funds made available by the American
21 Recovery and Reinvestment Act of 2009.

1 Section 20. The sum of \$15,000,000, or so much thereof
 2 as may be necessary, is appropriated from the Criminal
 3 Justice Trust Fund to the Illinois Criminal Justice
 4 Information Authority for awards and grants to state
 5 agencies.

6 Section 25. The additional sum of \$3,000,000, or so much
 7 thereof as may be necessary, is appropriated from the
 8 Criminal Justice Trust Fund to the Illinois Criminal Justice
 9 Information Authority for Byrne/JAG awards and grants to
 10 state agencies in accordance with applicable laws and
 11 regulations for the State portion of federal funds made
 12 available by the American Recovery and Reinvestment Act of
 13 2009.

14 Section 30. The following named sums, or so much thereof
 15 as may be necessary, are appropriated to the Illinois
 16 Criminal Justice Information Authority for activities
 17 undertaken in support of federal assistance programs
 18 administered by units of state and local government and non-
 19 profit organizations:

 22 American Recovery and Reinvestment

4 Section 35. The following named amounts, or so much
5 thereof as may be necessary, are appropriated to the Illinois
6 Criminal Justice Information Authority for awards and grants
7 and other monies received from federal agencies, from other
8 units of government, and from private/not-for-profit
9 organizations for activities undertaken in support of
10 investigating issues in criminal justice and for undertaking
11 other criminal justice information projects:

17 Section 40. The following named amounts, or so much
18 thereof as may be necessary, respectively, for the objects

20 Illinois Criminal Justice Information Authority for awards,
21 grants and operational support to implement the Motor Vehicle
22 Theft Prevention Act:

14 Section 45. The sum of \$4,500,000, or so much thereof as
 15 may be necessary, is appropriated from the Juvenile
 16 Accountability Incentive Block Grant Trust Fund to the
 17 Illinois Criminal Justice Information Authority for awards
 18 and grants to state agencies and units of local government,
 19 including operational expenses of the Authority in support of
 20 the Juvenile Accountability Incentive Block Grant program.

21 Section 50. The sum of \$25,000, or so much thereof as
 22 may be necessary, is appropriated from the Illinois State
 23 Crime Stoppers Association Fund to the Illinois Criminal

1 Justice Information Authority for grants to enhance and
2 develop Crime Stoppers programs in Illinois.

3 Section 55. The following named amounts, or so much
4 thereof as may be necessary, respectively, for the objects
5 and purposes hereinafter named, are appropriated to the
6 Illinois Criminal Justice Information Authority for the
7 training of law enforcement personnel and services for
8 families of homicide or murder:

22 Section 60. The sum of \$150,000, or so much thereof as
23 may be necessary, is appropriated from the Prescription Pill

1 and Drug Disposal Fund to the Illinois Criminal Justice
 2 Information Authority for the purpose of collection,
 3 transportation, and incineration of pharmaceuticals by local
 4 law enforcement agencies.

5 Section 65. The following amounts, or so much thereof as
 6 may be necessary, respectively, are appropriated for the
 7 objects and purposes named, to meet the ordinary and
 8 contingent expenses of the Illinois Criminal Justice
 9 Information Authority:

1 Section 70. The sum of \$1,200,000, or so much thereof as
2 may be necessary, is appropriated from the ICJIA Violence
3 Prevention Fund to the Illinois Criminal Justice Information
4 Authority for the purpose of awarding grants under the
5 provisions of the Violence Prevention Act of 1995.

6 Section 75. The sum of \$1,000,000, or so much thereof as
7 may be necessary, is appropriated from the General Revenue
8 Fund to the Illinois Criminal Justice Information Authority
9 for the purpose of awarding grants, contracts, administrative
10 expenses and all related costs for violence prevention
11 programs.

12 Section 80. The amount of \$544,500, or so much thereof
13 as may be necessary, is appropriated from the General Revenue
14 Fund to the Illinois Criminal Justice Information Authority
15 for the Illinois Family Violence Coordinating Council
16 Program.

17 Section 85. The amount of \$273,000, or so much thereof
18 as may be necessary, is appropriated from the General Revenue
19 Fund to the Illinois Criminal Justice Information Authority
20 for all costs associated with Bullying Prevention.

1 Section 90. The amount of \$15,000,000, or so much
2 thereof as may be necessary, is appropriated from the General
3 Revenue Fund to the Illinois Criminal Justice Information
4 Authority for grants and administrative expenses associated
5 with community-based violence prevention programs.

6 Section 95. The amount of \$5,000,000, or so much thereof
7 as may be necessary, is appropriated from the General Revenue
8 Fund to the Illinois Criminal Justice Information Authority
9 for administrative costs and grants to the Chicago Area
10 Project.

11 Section 100. The amount of \$4,400,000, or so much
12 thereof as may be necessary, is appropriated from the General
13 Revenue Fund to the Illinois Criminal Justice Information
14 Authority for grants and administrative expenses related to
15 Operation CeaseFire.

16 Section 105. The amount of \$1,200,000, or so much
17 thereof as may be necessary, is appropriated from the General
18 Revenue Fund to the Illinois Criminal Justice Information
19 Authority for grants and administrative expenses for Franklin
20 County Juvenile Detention Center for Methamphetamine Pilot
21 Program.

1 Section 110. The amount of \$1,000,000, or so much
2 thereof as may be necessary, is appropriated from the General
3 Revenue Fund to the Illinois Criminal Justice Information
4 Authority for grants and administrative expenses for Cook
5 County Vocational Rehabilitation Impact Center.

6 Section 999. Effective date. This Act takes effect July 1,
7 2013.
