A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named sums, or so much thereof
6 as may be necessary, respectively, for the objects and
7 purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Arts
9 Council:

10 Payable from the General Revenue Fund:

11	For Personal Services	1,280,000
12	For State Contributions to

14	For Contractual Services	138,200
15	For Travel	20,000

1 Section 5. The following named sums, or so much thereof
 2 as may be necessary, respectively, for the objects and
 3 purposes hereinafter named, are appropriated to the Illinois
 4 Arts Council to enhance the cultural environment in Illinois:

6	For Grants and Financial Assistance for	
7	Creative Sector (Arts Organizations and	
8	Individual Artists)	3,813,300
9	For Grants and Financial Assistance for

14 Payable from the Illinois Arts Council

15 Federal Grant Fund:

16	For Grants and Programs to Enhance

18	For the purposes of Administrative

21 Section 10. The sum of \$315,000, or so much thereof as
 22 may be necessary, is appropriated from the General Revenue
 23 Fund to the Illinois Arts Council for the purpose of funding
 24 administrative and grant expenses associated with humanities

1 programs and related activities.

2 Section 15. The amount of \$1,781,300, or so much thereof
3 as may be necessary, is appropriated from the General Revenue
4 Fund to the Illinois Arts Council for grants to certain
5 public radio and television stations and related
6 administrative expenses, pursuant to the Public Radio and
7 Television Grant Act.

8 Section 20. In addition to other amounts appropriated
9 for this purpose, the following named sum, or so much thereof
10 as may be necessary, respectively, for the object and purpose
11 hereinafter named, is appropriated to the Illinois Arts
12 Council to enhance the cultural environment in Illinois:

13 Payable from Illinois Arts Council

14 Federal Grant Fund:

15 For Grants and Programs to Enhance

16 the Cultural Environment and associated

17 administrative costs65,000
