2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Fox Waterway Agency Act is amended by
5 changing Section 1 and by adding Section 1.01 as follows:

7 Sec. 1. This Act shall be known and may be cited as the Fox
8 Waterway Agency Dissolution Act.

11 Sec. 1.01. Dissolution. The Fox Waterway Agency is
12 dissolved. On the effective date of this amendatory Act of the
13 98th General Assembly, all the assets and property of the Fox
14 Waterway Agency shall by operation of law vest in and be
15 assumed by the Department of Natural Resources.
