

98TH GENERAL ASSEMBLY State of Illinois 2013 and 2014 SB3124

SYNOPSIS AS INTRODUCED:

305 ILCS 5/5-33 new 305 ILCS 5/5-34 new

Amends the Medical Assistance Article of the Illinois Public Aid Code. Requires the Department of Healthcare and Family Services to promulgate rules to increase by \$10 for State fiscal year 2015 the total monthly personal needs allowance for persons who are inpatients in a facility licensed under the ID/DD Community Care Act for which payments are made under the Medical Assistance Article throughout a month and who are determined to be eligible for medical assistance. Provides that for State fiscal years 2016 and beyond, in any calendar year in which there is a cost-of-living increase in federal Supplemental Security Income benefits or Social Security benefits, the Department shall promulgate rules to increase the total monthly personal needs allowance by an amount that is at least equal to the increase in federal Supplemental Security Income benefits or Social Security benefits. Provides that the Department shall not be prohibited from increasing, by rule, for State fiscal years 2016 and beyond, the personal needs allowance by an amount that is greater than the cost-of-living increase in federal Supplemental Security Income benefits or Social Security benefits for that calander year; and that at no time shall the personal needs allowance for eligible persons be reduced below the rates calculated for State fiscal year 2015. Authorizes the Department to make similar increases, by rule, for persons who reside in a facility licensed under the Community-Integrated Living Arrangements Licensure and Certification Act, who are determined to be eligible for medical assistance, and who are enrolled in the Illinois Home and Community Based Services Medicaid Waiver program for adults with developmental disabilities. Effective immediately.

FISCAL NOTE ACT MAY APPLY

1 AN ACT concerning public aid.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Public Aid Code is amended by adding Sections 5-33 and 5-34 as follows:
- 6 (305 ILCS 5/5-33 new)
- 7 <u>Sec. 5-33. Personal needs allowance; ID/DD facility.</u>
- (a) The Department shall promulgate rules to increase by 8 9 \$10 for State fiscal year 2015 the total monthly personal needs allowance for persons who are inpatients in a facility licensed 10 under the ID/DD Community Care Act for which payments are made 11 12 under this Article throughout a month and who are determined to be eligible for medical assistance under this Article. For 13 14 State fiscal years 2016 and beyond, in any calendar year in which there is a cost-of-living increase in federal 15 Supplemental Security Income benefits or Social Security 16 17 benefits, the Department shall promulgate rules to increase the total monthly personal needs allowance by an amount that is at 18 19 least equal to the increase in federal Supplemental Security 20 Income benefits or Social Security benefits. Nothing in this 21 Section shall prohibit the Department from increasing, by rule, 22 for State fiscal years 2016 and beyond, the personal needs allowance by an amount that is greater than the cost-of-living 23

- 10 <u>allowance for persons who reside in a facility licensed under</u>
- 11 the Community-Integrated Living Arrangements Licensure and
- 12 Certification Act, who are determined to be eligible for
- 13 medical assistance under this Article, and who are enrolled in
- 14 the Illinois Home and Community Based Services Medicaid Waiver
- 15 program for adults with developmental disabilities. For State
- 16 fiscal years 2016 and beyond, in any calendar year in which
- 17 there is a cost-of-living increase in federal Supplemental
- 18 Security Income benefits or Social Security benefits, the
- 19 Department shall promulgate rules to increase the total monthly
