SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.866 new
625 ILCS 5/3-699.14 new

Amends the State Finance Act. Creates the Little League Fund. Amends the Illinois Vehicle Code. Provides that the Secretary of State may issue Little League Plates. Provides that the cost of initial issuance of these plates shall cost \$25 in addition to any other fees, \$10 of which will go to the Little League Fund and \$15 of which will go to the Secretary of State Special License Plate Fund. Provides that renewal of these plates will cost \$25, \$23 of which will go to the Little League Fund and \$2 of which will go to the Secretary of State Special License Plate Fund. Allows for distribution, subject to appropriation, of money from the Little League Fund as grants to local little league organizations in proportion to their membership size.

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The State Finance Act is amended by adding
5 Section 5.866 as follows:

6 (30 ILCS 105/5.866 new)

7 Sec. 5.866. The Little League Fund.

8 Section 10. The Illinois Vehicle Code is amended by adding
9 Section 3-699.14 as follows:

10 (625 ILCS 5/3-699.14 new)

11 Sec. 3-699.14. Little League plates.

12 (a) The Secretary, upon receipt of all applicable fees and
13 applications made in the form prescribed by the Secretary, may
14 issue special registration plates designated as Little League
15 license plates. The special plates issued under this Section
16 shall be affixed only to passenger vehicles of the first
17 division or motor vehicles of the second division weighing not
18 more than 8,000 pounds. Plates issued under this Section shall
19 expire according to the multi-year procedure established by
20 Section 3-414.1 of this Code.

21 (b) The design and color of the special plates shall be

1 wholly within the discretion of the Secretary. Appropriate
2 documentation, as determined by the Secretary, shall accompany
3 each application.

4 (c) An applicant for the special plate shall be charged a
5 \$25 fee for original issuance in addition to the appropriate
6 registration fee. Of this fee, \$10 shall be deposited into the
7 Little League Fund and \$15 shall be deposited into the
8 Secretary of State Special License Plate Fund, to be used by
9 the Secretary to help defray the administrative processing
10 costs.

11 For each registration renewal period, a \$25 fee, in
12 addition to the appropriate registration fee, shall be charged.
13 Of this fee, \$23 shall be deposited into the Little League Fund
14 and \$2 shall be deposited into the Secretary of State Special
15 License Plate Fund.

16 (d) The Little League Fund is created as a special fund in
17 the State treasury. All money in the Little League Fund shall
18 be paid, subject to appropriation by the General Assembly and
19 distribution by the Secretary, as grants to local little league
20 organizations in proportion to their membership size.
