SYNOPSIS AS INTRODUCED:

805 ILCS 180/50-10

Amends the Limited Liability Company Act. Reduces filing fees imposed upon limited liability companies by 50%. Effective immediately.

FISCAL NOTE ACT MAY APPLY 1 AN ACT concerning limited liability companies.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Limited Liability Company Act is amended by changing Section 50-10 as follows:
- 6 (805 ILCS 180/50-10)
- 7 Sec. 50-10. Fees.
- 8 (a) The Secretary of State shall charge and collect in 9 accordance with the provisions of this Act and rules 10 promulgated under its authority all of the following:
- 11 (1) Fees for filing documents.
- 12 (2) Miscellaneous charges.
- 13 (3) Fees for the sale of lists of filings and for copies of any documents.
- 15 (b) The Secretary of State shall charge and collect for all of the following:
- 17 articles of organization (domestic), (1)Filing application for admission (foreign), and restated articles 18 19 of organization (domestic), \$250 \\$500. Notwithstanding the foregoing, the fee for filing articles of organization 20 21 (domestic), application for admission (foreign), 22 restated articles of organization (domestic) in connection with a limited liability company with ability to establish 23

- 2 (2) Filing articles of amendment or an amended application for admission, \$75 \frac{\frac{150}}{5}.
 - (3) Filing articles of dissolution or application for withdrawal, \$50 \$100.
 - (4) Filing an application to reserve a name, \$150 \$300.
 - (5) Filing a notice of cancellation of a reserved name, \$50 \$100.
 - (6) Filing a notice of a transfer of a reserved name, \$50
 - (7) Registration of a name, \$150 \$300.
 - (8) Renewal of registration of a name, \$50 \$100.
 - (9) Filing an application for use of an assumed name under Section 1-20 of this Act, $\frac{\$75}{\$150}$ for each year or part thereof ending in 0 or 5, $\frac{\$60}{\$60}$ for each year or part thereof ending in 1 or 6, $\frac{\$45}{\$90}$ for each year or part thereof ending in 2 or 7, $\frac{\$30}{\$60}$ for each year or part thereof ending in 3 or 8, $\frac{\$15}{\$30}$ for each year or part thereof ending in 4 or 9, and a renewal for each assumed name, $\frac{\$75}{\$150}$.
 - (10) Filing an application for change or cancellation of an assumed name, $\frac{$50}{}$
 - (11) Filing an annual report of a limited liability company or foreign limited liability company, $\frac{$125}{$250}$, if filed as required by this Act, plus a penalty if delinquent. Notwithstanding the foregoing, the fee for

- filing an annual report of a limited liability company or foreign limited liability company with ability to establish series is \$125 \$250 plus \$25 \$50 for each series for which a certificate of designation has been filed pursuant to Section 37-40 of this Act and active on the last day of the third month preceding the company's anniversary month, plus a penalty if delinquent.
 - (12) Filing an application for reinstatement of a limited liability company or foreign limited liability company \$250 \$500.
 - (13) Filing Articles of Merger, $\frac{$50}{100}$ plus $\frac{$25}{50}$ for each party to the merger in excess of the first 2 parties.
 - (14) Filing an Agreement of Conversion or Statement of Conversion, \$50 \$100.
 - (15) Filing a statement of change of address of registered office or change of registered agent, or both, or filing a statement of correction, \$12.50
 - (16) Filing a petition for refund, \$7.50 \$15.
 - (17) Filing any other document, \$50 \$100.
- (18) Filing a certificate of designation of a limited liability company with the ability to establish series pursuant to Section 37-40 of this Act, \$25 \$50.
- (c) The Secretary of State shall charge and collect all of the following:
- 26 (1) For furnishing a copy or certified copy of any

- document, instrument, or paper relating to a limited liability company or foreign limited liability company, or for a certificate, \$12.50 \cdot \frac{\$25}{}.
- 4 (2) For the transfer of information by computer process
 5 media to any purchaser, fees established by rule <u>in an</u>
 6 <u>amount that does not exceed 50% of the amount of the fee in</u>
 7 effect on January 1, 2016.
