## Be it enacted by the People of the State of Illinois, 2 represented in the General Assembly: 3

Library and museum 22 material made or acquired and preserved solely for reference or exhibition purposes, extra copies of documents preserved only 23

for convenience of reference, and stocks of publications and of blank forms are not included within the definition of records as used in this Act. Reports of impaired physicians under Section 16.04 of the Medical Practice Act or Section 23 of the Medical Practice Act of 1987 are not included within the definition of records as used in this Act.

Sec. 7. Disposition rules. Except as otherwise provided by law, no public record shall be disposed of by any officer or agency unless the written approval of the appropriate Local Records Commission is first obtained.

1 schedules of public records proposed for disposal; and 2 procedures for the physical destruction or other disposition of 3 such public records; procedures for the management and preservation of electronically generated and maintained 4 5 records; and standards for the reproduction of such public photography, microphotographic processes, 6 records by or 7 digitized electronic format. Such standards shall relate to the 8 quality of the film to be used, preparation of the public 9 records for filming or electronic conversion, proper 10 identification matter on such records so that an individual 11 document or series of documents can be located on the film or 12 digitized electronic form with reasonable facility, and that 13 the copies contain all significant record detail, to the end 14 that the copies will be adequate. Any public record may be 15 reproduced in a microfilm or digitized electronic format. The 16 agency may dispose of the original of any reproduced record 17 providing: (i) the reproduction process forms a durable medium that accurately and legibly reproduces the original record in 18 19 all details, that does not permit additions, deletions, or 20 changes to the original document images, and, if electronic, that are retained in a trustworthy manner so that the records, 21 22 and the information contained in the records, are accessible 23 and usable for subsequent reference at all times while the 24 information must be retained, (ii) the reproduction is retained 25 for the prescribed retention period, and (iii) the Commission 26 is notified when the original record is disposed of and also

1 when the reproduced record is disposed of.

Such regulations shall also provide that the State archivist may retain any records which the Commission has authorized to be destroyed, where they have a historical value, and that the State archivist may deposit them in the State Archives, State Historical Library, or a university library, or with a historical society, museum, or library.

Sec. 12. Both Commissions shall with the assistance of the 10 11 Secretary of State and State Archivist determine what records 12 are essential for emergency government operation through consultation with all branches of government, state agencies, 13 14 and with the Illinois Emergency Management Agency State 15 Civilian Defense agency, to determine what records are 16 essential for post-emergency government operation and provide for their protection and preservation and provide for the 17 security storage or relocation of essential local records in 18 19 the event of an emergency arising from enemy attack or natural 20 disaster.
