SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-699.14 new

Amends the Illinois Vehicle Code to provide for the issuance of I.A.F.F. plates. Provides that the applicant shall pay an additional fee of \$27 for original issuance of the plates, of which \$12 shall be deposited into the Fire Prevention Fund and \$15 shall be deposited into the Secretary of State Special License Plate Fund. Provides that an additional fee of \$17 shall be charged for each renewal, of which \$15 shall be deposited into the Fire Prevention Fund and \$2 shall be deposited into the Special License Plate Fund.

FISCAL NOTE ACT MAY APPLY

1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by adding Section 3-699.14 as follows:
- 6 (625 ILCS 5/3-699.14 new)
- 7 <u>Sec. 3-699.14. I.A.F.F. plates.</u>
- 8 (a) The Secretary, upon receipt of all applicable fees and
- 9 applications made in the form prescribed by the Secretary of
- 10 State, may issue special registration plates designated as
- 11 <u>I.A.F.F.</u> (International Association of Fire Fighters) plates
- 12 <u>to active union affiliated firefighters who reside in Illinois.</u>
- 13 The special plates issued under this Section shall be affixed
- 14 <u>only to passenger vehicles of the first division or motor</u>
- vehicles of the second division weighing not more than 8,000
- 16 <u>lbs. Plates issued under this Section shall expire according to</u>
- the multi-year procedure established by Section 3-414.1 of this
- 18 <u>Code</u>.
- 19 (b) The design and color of the special plates shall be
- 20 wholly within the discretion of the Secretary. Appropriate
- documentation, as determined by the Secretary, shall accompany
- 22 <u>each application</u>.
- (c) An applicant shall be charged a \$27 fee for original

issuance in addition to the appropriate registration fee, if applicable. Of this fee, \$12 shall be deposited into the Fire Prevention Fund and \$15 shall be deposited into the Secretary of State Special License Plate Fund. For each registration renewal period, a \$17 fee, in addition to the appropriate registration fee, shall be charged. Of this fee, \$15 shall be deposited into the Fire Prevention Fund and \$2 shall be deposited into the Secretary of State Special License Plate Fund.
