#### SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-699.14 new

Amends the Illinois Vehicle Code to provide for the issuance of Professional Firefighter plates. Provides that the applicant shall pay an additional fee of \$27 for original issuance of the plates, of which \$12 shall be deposited into the Fire Prevention Fund and \$15 shall be deposited into the Secretary of State Special License Plate Fund. Provides that an additional fee of \$17 shall be charged for each renewal, of which \$15 shall be deposited into the Fire Prevention Fund and \$2 shall be deposited into the Secretary of State Special License Plate Fund.

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Vehicle Code is amended by adding  
5 Section 3-699.14 as follows:

6 (625 ILCS 5/3-699.14 new)

7 Sec. 3-699.14. Professional Firefighter plates.

8 (a) The Secretary, upon receipt of all applicable fees and  
9 applications made in the form prescribed by the Secretary of  
10 State, may issue special registration plates designated as  
11 Professional Firefighter plates to active full time  
12 firefighters who reside in Illinois. The special plates issued  
13 under this Section shall be affixed only to passenger vehicles  
14 of the first division or motor vehicles of the second division  
15 weighing not more than 8,000 lbs. Plates issued under this  
16 Section shall expire according to the multi-year procedure  
17 established by Section 3-414.1 of this Code.

18 (b) The design and color of the special plates shall be  
19 wholly within the discretion of the Secretary. Appropriate  
20 documentation, as determined by the Secretary, shall accompany  
21 each application.

22 (c) An applicant shall be charged a \$27 fee for original  
23 issuance in addition to the appropriate registration fee, if

1 applicable. Of this fee, \$12 shall be deposited into the Fire  
2 Prevention Fund and \$15 shall be deposited into the Secretary  
3 of State Special License Plate Fund. For each registration  
4 renewal period, a \$17 fee, in addition to the appropriate  
5 registration fee, shall be charged. Of this fee, \$15 shall be  
6 deposited into the Fire Prevention Fund and \$2 shall be  
7 deposited into the Secretary of State Special License Plate  
8 Fund.
