The Park District Code is amended by adding 4 Section 8-23a as follows: 5 6 (70 ILCS 1205/8-23a new) 7 Sec. 8-23a. Application for volunteers; disclosure of sex offenses; penalty for failure to disclose. 8 (a) For purposes of this Section, "sex offense" means: 9 10 (1) any offense defined in Sections 11-6, 11-9 through 11 11-9.5, inclusive, and 11-30, of the Criminal Code of 1961 or the Criminal Code of 2012; Sections 11-14 through 11-21, 12 13 inclusive, of the Criminal Code of 1961 or the Criminal Code of 2012; Sections 11-23 (if punished as a Class 3 14 15 felony), 11-24, 11-25, and 11-26 of the Criminal Code of

1961 or the Criminal Code of 2012; and Sections 11-1.20,

1	11-1.30, 11-1.40, 11-1.50, 11-1.60, 12-4.9, 12-13, 12-14,
2	12-14.1, 12-15, 12-16, 12-32, 12-33, and 12C-45 of the
3	Criminal Code of 1961 or the Criminal Code of 2012;
4	(2) any attempt to commit any of the offenses listed in
5	<pre>paragraph (1) of this definition;</pre>
6	(3) any offense committed or attempted in any other
7	state that, if committed or attempted in this State, would
8	have been punishable as one or more of the offenses listed
9	in paragraphs (1) and (2) of this definition; and
10	(4) sexual or physical abuse of any minor under 18
11	years of age that subjects a perpetrator to proceedings
12	under Article II of the Juvenile Court Act of 1987.
13	(b) For purposes of this Section, "volunteer" means any
14	individual who without compensation or benefits reports to, and
15	is under the direct supervision of, a park district's
16	administrative staff and provides personal services to a park
17	district recreational program that is offered to children.
18	(c) Every park district shall require volunteers to
19	complete an application prior to beginning any work as a
20	volunteer. The application shall include, but shall not be
21	limited to, a question for the applicant to answer concerning
22	whether they have been convicted of or found to be the
23	perpetrator of a sex offense. No park district shall knowingly
24	engage a volunteer who has been convicted of or found to be the
25	perpetrator of a sex offense and shall terminate the services

of the volunteer upon discovery of such offense.

- 1 (d) If a current volunteer with a park district is 2 convicted of or found to be the perpetrator of a sex offense, the volunteer shall immediately disclose the conviction or 3 4 finding to the park district.
 - (e) Failure of a volunteer to disclose that they are a sex offender pursuant to this Section is a Class 3 felony. Any person who is convicted for a violation under this subsection for a second or subsequent time is guilty of a Class 2 felony. Any person convicted of a violation under this subsection shall, in addition to any other penalty required by law, be required to serve a minimum period of 7 days confinement in the local county jail, and the court shall impose a mandatory minimum fine of \$500. These fines shall be deposited in the Sex Offender Registration Fund.
- Section 99. Effective date. This Act takes effect upon 15 16 becoming law.".
