Amend House Bill 2557 as follows: 3 on page 1, line 5, by replacing "Section 1.3" with "Sections 1.1 and 1.3"; and 4 5 on page 1, below line 5, by inserting the following: "(230 ILCS 25/1.1) 6 Sec. 1.1. Definitions. For purposes of this Act, the 7 8 following definitions apply: 9 "Bingo" means a game in which each player has a card or board for which a consideration has been paid, containing 5 10 11 horizontal rows of spaces, with each row except the central one 12 containing 5 figures. The central row has 4 figures with the word "free" marked in the center space. "Bingo" includes games 13

that otherwise qualify under this paragraph, except for the use

of cards where the figures are not preprinted but are filled in

- 1 by the players. A player wins a game of bingo by completing a
- 2 preannounced combination of spaces or, in the absence of a
- 3 preannouncement of a combination of spaces, any combination of
- 5 spaces in a row, vertically, horizontally, or diagonally.
- 5 "Bingo equipment" means any equipment or machinery
- 6 designed or used for the play of bingo. "Bingo equipment" does
- 7 not include electronic equipment.
- 8 "Charitable organization" means an organization or
- 9 institution organized and operated to benefit an indefinite
- 10 number of the public.
- "Department" means the Department of Revenue.
- 12 "Educational organization" means an organization or
- institution organized and operated to provide systematic
- instruction in useful branches of learning by methods common to
- schools and institutions of learning which compare favorably in
- their scope and intensity with the course of study presented in
- 17 tax-supported schools.
- "Fraternal organization" means an organization of persons
- 19 having a common interest that is organized and operated
- 20 exclusively to promote the welfare of its members and to
- 21 benefit the general public on a continuing and consistent
- 22 basis, including but not limited to ethnic organizations.
- "Holiday" means any of the holidays listed in Section 17 of
- the Promissory Note and Bank Holiday Act.
- 25 "Labor organization" means an organization composed of
- labor unions or workers organized with the objectives of

- 1 betterment of the conditions of those engaged in such pursuit
- and the development of a higher degree of efficiency in their 2
- 3 respective occupations.
- 4 "Licensed organization" means a qualified organization
- 5 that has obtained a license to conduct bingo in conformance
- with the provisions of this Act. 6
- "Limited license" means a license issued to an organization 7
- 8 that is not a licensed organization, but that is otherwise
- 9 eligible for a regular license to conduct bingo. A limited
- 10 license authorizes the conduct of bingo at up to 2 indoor or
- 11 outdoor festivals during the calendar year for which the
- license is issued for a maximum of 5 consecutive days on each 12
- 13 occasion.
- 14 "Non-profit organization" means an organization
- 15 institution organized and conducted on a not-for-profit basis
- 16 with no personal profit inuring to anyone as a result of the
- 17 operation.
- "Organization" means a corporation, agency, partnership, 18
- association, firm, business or other entity consisting of 2 or 19
- 20 more persons joined by a common interest or purpose.
- 21 "Person" means any natural individual, corporation,
- 22 partnership, limited liability company, organization
- 23 defined in this Section), licensee under this Act,
- 24 volunteer.
- 25 "Provider" means any person or organization, except a city,
- 26 village, or incorporated town that owns or leases premises to

- 1 an organization for the conduct of bingo.
- 2 "Regular license" means a license authorizing its holder to
- conduct one session of bingo per week on the date and at the 3
- 4 time and location stated on the license.
- 5 "Religious organization" means any church, congregation,
- 6 society, or organization founded for the purpose of religious
- 7 worship.
- 8 "Senior citizens organization" means an organization or
- 9 association comprised of members of which substantially all are
- 10 individuals who are senior citizens, as defined in the Illinois
- 11 Act on the Aging, the primary purpose of which is to promote
- the welfare of its members. 12
- 13 "Special games" means bingo games that may be designated as
- such, played a maximum of 5 times during a bingo session and 14
- 15 are distinguished from regular games only by the maximum price
- 16 that may be charged for the bingo cards used.
- "Special permit" means the ability of a licensee who 17
- currently holds a license to be granted a permit to conduct 18
- bingo at other premises or on other days not exceeding 5 19
- 20 consecutive days.
- "Supplier" means any person, firm, or corporation that 21
- 22 sells, leases, or distributes to any organization licensed to
- 23 conduct bingo or to any licensed bingo supplier, cards, boards,
- 24 sheets, markers, pads and any other supplies, devices and
- 25 equipment designed for use in the play of bingo.
- 26 "Veterans' organization" means an organization comprised

- of members of which substantially all are individuals who are
- 2 veterans or spouses, widows, or widowers of veterans, the
- 3 primary purpose of which is to promote the welfare of its
- 4 members and to provide assistance to the general public in such
- 5 a way as to confer a public benefit.
- 6 "Volunteer" means a person recruited by an organization who
- 7 voluntarily performs services at a bingo event, including
- 8 participation in the management or operation of a game.
- 9 "Youth athletic organization" means an organization having
- 10 as its exclusive purpose the promotion and provision of
- 11 athletic activities for youth aged 18 and under.

- on page 3, below line 26, by inserting the following:
- "Section 99. Effective date. This Act takes effect upon
- 15 becoming law.".
