A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much
5 thereof as may be necessary, respectively, are appropriated
6 to the Court of Claims for its ordinary and contingent
7 expenses:

9 Payable from the General Revenue Fund:

2 Section 10. The amount of \$450,000, or so much of that
3 amount as may be necessary, is appropriated from the Court of
4 Claims Administration and Grant Fund to the Court of Claims
5 for administrative expenses under the Crime Victims
6 Compensation Act.

7 Section 15. The following named amounts, or so much of
8 that amount as may be necessary, are appropriated to the
9 Court of Claims for payment of claims as follows:

10 For claims under the Crime Victims
11 Compensation Act:

12 Payable from the Court of Claims
13 Federal Grant Fund10,000,000

14 Section 20. The amount of \$1,000,000, or so much thereof
15 as may be necessary, is appropriated from the General Revenue
16 Fund to the Court of Claims for payment of awards solely as a
17 result of the lapsing of an appropriation originally made
18 from any funds held by the State Treasurer.

19 Section 25. The sum of \$5,000,000, or so much thereof as
20 may be necessary, is appropriated from the General Revenue
21 Fund to the Court of Claims for payment of line of duty

1 awards.

2 Section 30. The following named amounts, or so much
3 thereof as may be necessary, is appropriated to the Court of
4 Claims for payment of claims as follows:

5 For claims under the Crime Victims

6 Compensation Act:

7 Payable from General Revenue Fund6,000,000

8 For claims other than Crime Victims:

9 Payable from the General Revenue Fund9,807,400

10 Total\$15,807,400

11 Section 35. The following named amounts, or so much of
12 that amount as may be necessary, are appropriated to the
13 Court of Claims for payment of claims as follows:
