SYNOPSIS AS INTRODUCED:

105 ILCS 5/10-20.19a from Ch. 122, par. 10-20.19a 105 ILCS 5/10-22.18 from Ch. 122, par. 10-22.18

Amends the School Code. In a Section concerning kindergartens, provides that, beginning with the 2017-2018 school year, each school board must establish a kindergarten with full-day attendance (instead of allowing a school board to establish a kindergarten with half-day attendance or with full-day attendance); makes related changes. Repeals another Section concerning kindergartens on July 1, 2017. Effective immediately.

FISCAL NOTE ACT MAY APPLY

STATE MANDATES ACT MAY REQUIRE REIMBURSEMENT 1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The School Code is amended by changing Sections 10-20.19a and 10-22.18 as follows:
- 6 (105 ILCS 5/10-20.19a) (from Ch. 122, par. 10-20.19a)
- Sec. 10-20.19a. Kindergartens. After July 1, 1970, to 8 establish and maintain kindergartens for the instruction of 9 children in accordance with rules and regulations prescribed by
- the State Board of Education. Such kindergartens may provide
- 11 for either a 1/2 day or a full day of attendance for pupils
- 12 enrolled therein.
- This Section is repealed on July 1, 2017.

- 15 (105 ILCS 5/10-22.18) (from Ch. 122, par. 10-22.18)
- Sec. 10-22.18. Kindergartens. To establish kindergartens
- for the instruction of children between the ages of 4 and 6
- 18 years, if in their judgment the public interest requires it,
- 19 and to pay the necessary expenses thereof out of the school
- funds of the district. Until the 2017-2018 school year, upon
- $\frac{1}{2}$ Upon petition of at least 50 parents or guardians of children
- 22 between the ages of 4 and 6, residing within any school

- 1 district and within one mile of the public school where such 2 kindergarten is proposed to be established, the board of 3 shall, if funds directors are available, establish 4 kindergarten in connection with the public school designated in 5 the petition and maintain it as long as the annual average 6 daily attendance therein is not less than 15. Until the 7 2017-2018 school year, the The board may establish a kindergarten with half-day attendance or with 8 full-day 9 attendance; however, if. If the board establishes full-day 10 kindergarten, it shall also establish half-day kindergarten. 11 Beginning with the 2017-2018 school year, each school board 12 must establish a kindergarten with full-day attendance. No one 13 shall be employed to teach in a kindergarten who does not hold a license certificate as provided by law. 14
- Section 99. Effective date. This Act takes effect upon becoming law.
