In the event that the University violates this 7 8 Section, the State Comptroller shall debit from the 9 University's State operating aid an amount equal to the amount 10 paid by the University to the commencement speaker.

### Section 15. The Chicago State University Law is amended by adding Section 5-185 as follows:

#### 13 (110 ILCS 660/5-185 new) Sec. 5-185. Commencement speaker; State funds prohibition. 14 The University may not use State funds to pay an individual to 15 16 deliver the commencement address at any graduation ceremony 17 conducted by the University, but may use private funds for such purposes. In the event that the University violates this 18 19 Section, the State Comptroller shall debit from the 20 University's State operating aid an amount equal to the amount

21 paid by the University to the commencement speaker.

Section 20. The Eastern Illinois University Law is amended

In the event that the 7 8 University violates this Section, the State Comptroller shall debit from the University's State operating aid an amount equal 9 10 to the amount paid by the University to the commencement speaker. 11

Section 25. The Governors State University Law is amended by adding Section 15-185 as follows:

(110 ILCS 670/15-185 new) 14 15 Sec. 15-185. Commencement speaker; State funds 16 prohibition. The University may not use State funds to pay an 17 individual to deliver the commencement address at any 18 graduation ceremony conducted by the University, but may use 19 private funds for such purposes. In the event that the University violates this Section, the State Comptroller shall 20 21 debit from the University's State operating aid an amount equal 22 to the amount paid by the University to the commencement 23 speaker.

Section 30. The Illinois State University Law is amended by
 adding Section 20-190 as follows:

3 (110 ILCS 675/20-190 new) Sec. 20-190. Commencement speaker; State funds 4 prohibition. The University may not use State funds to pay an 5 individual to deliver the commencement address at any 6 7 graduation ceremony conducted by the University, but may use 8 private funds for such purposes. In the event that the 9 University violates this Section, the State Comptroller shall debit from the University's State operating aid an amount equal 10 11 to the amount paid by the University to the commencement 12 speaker.

Section 35. The Northeastern Illinois University Law is amended by adding Section 25-185 as follows:

16 25-185. Commencement speaker; State Sec. funds 17 prohibition. The University may not use State funds to pay an individual to deliver the commencement address at any 18 graduation ceremony conducted by the University, but may use 19 20 private funds for such purposes. The University may not use State funds to pay an 8 individual to deliver the commencement address at any 9 graduation ceremony conducted by the University, but may use 10 private funds for such purposes. In the event that the University violates this Section, the State Comptroller shall 11 12 debit from the University's State operating aid an amount equal 13 to the amount paid by the University to the commencement 14 speaker.
- Section 45. The Western Illinois University Law is amended by adding Section 35-190 as follows:
