

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following amounts, or so much thereof as  
6 may be necessary, are appropriated to the Department of  
7 Military Affairs for costs associated with Lincoln's  
8 Challenge:

9	Payable from the General Revenue Fund .....	230,400
10	Payable from the Federal Support	
11	Agreement Revolving Fund .....	<u>716,700</u>
12	Total	\$947,100

13 Section 10. This Article shall not be effective if SB  
14 2032 of the 99<sup>th</sup> General Assembly becomes law.

15 ARTICLE 2

16 Section 5. The following amounts, or so much thereof as  
17 may be necessary, are appropriated to the Department of  
18 Public Health for Breast and Cervical Cancer Screenings,  
19 minority outreach, and other related activities in Fiscal

1 Year 2016 and all prior fiscal years:

2	Payable from the General Revenue Fund.....	916,700
3	Payable from the Public Health Services Fund.....	<u>500,000</u>
4	Total	\$1,416,700

5 Section 10. The amount of \$1,840,000, or so much thereof  
6 as may be necessary, is appropriated from the General Revenue  
7 Fund to the Department of Public Health for Expenses of  
8 AIDS/HIV Education, Drugs, Services, Counseling, Testing,  
9 Outreach to Minority populations, costs associated with  
10 correctional facilities and Partner Notification (CTRPN), and  
11 Patient and Worker Notification pursuant to Public Act 87-  
12 763.

13 Section 15. This Article shall not be effective if SB  
14 2037 of the 99<sup>th</sup> General Assembly becomes law.

15 ARTICLE 3

16 Section 5. The following amounts, or so much thereof as  
17 may be necessary, are appropriated to the Department of Human  
18 Services for costs associated with the Domestic Violence  
19 Shelters and Services Program:

20	Payable from the General Revenue Fund.....	1,457,300
21	Payable from the Domestic Violence	

1	Shelter and Service Fund .....	<u>76,200</u>
2	Total	\$1,533,500

3 Section 10. The amount of \$344,000, or so much thereof as  
 4 may be necessary, is appropriated from the General Revenue  
 5 Fund to the Department of Human Services for a grant to the  
 6 Autism Program for an Autism Diagnosis Education Program for  
 7 Individuals.

8 Section 15. The following amounts, or so much thereof as  
 9 may be necessary, are appropriated to the Department of Human  
 10 Services for costs associated with the Early Intervention  
 11 Service Program, including prior year costs:

12	Payable from the General Revenue Fund .....	6,600,000
13	Payable from the Early Intervention	
14	Services Revolving Fund .....	<u>14,400,000</u>
15	Total	\$21,000,000

16 Section 20. The following amounts, or so much thereof as  
 17 may be necessary, are appropriated to the Department of Human  
 18 Services for Homeless Youth Services:

19	Payable from the General Revenue Fund .....	364,000
20	Payable from the Illinois Affordable	
21	Housing Trust Fund .....	<u>80,000</u>
