2 Section 10. The sum of \$125,000, or so much thereof as 3 may be necessary, is appropriated from the Fire Prevention 4 Fund to the Office of the State Fire Marshal for grants 5 available for costs and services related to ILEAS/MABAS 6 administration.

Section 15. The sum of \$3,816,200, or so much thereof as 7 8 may be necessary, is appropriated from the Fire Prevention 9 Fund to the Board of Trustees of the University of Illinois 10 for the purpose of maintaining the Illinois Fire Service 11 Institute, paying the Institute's expenses, and providing the 12 facilities and structures incident thereto, including payment to the University for personal services and related costs 13 14 incurred.

Section 20. The appropriation authority granted in this Article shall be valid only for costs incurred July 1, 2015 through June 30, 2016.
