

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 0.5

5 Section 1. It is the intent of the State that all or a  
6 portion of the costs of projects funded by appropriations  
7 made in this Act from the Capital Development Fund, the  
8 School Construction Fund, the Anti-Pollution Fund, the  
9 Transportation Bond Series A Fund, the Transportation Bond  
10 Series B Fund, the Coal Development Fund, the Transportation  
11 Bond Series D Fund, and the Build Illinois Bond Fund will be  
12 paid or reimbursed from the proceeds of tax-exempt bonds  
13 subsequently issued by the State.

14 ARTICLE 1

15 ARCHITECT OF THE CAPITOL

16 Section 5. The amount of \$3,883, or so much thereof as  
17 may be necessary and remains unexpended on June 30, 2015,  
18 from a reappropriation heretofore made for such purpose in  
19 Section 5 of Article 1 of Public Act 98-0675, is  
20 reappropriated from the Capital Development Fund to the

1 Office of the Architect of the Capitol for plans,  
2 specifications, and continuation of work pursuant to the  
3 report and recommendations of the architectural, structural,  
4 and mechanical surveys of the State Capitol Building. This  
5 is for the continuation of the rehabilitation of the Capitol  
6 Building.

7 Section 10. The sum of \$548,180, or so much thereof as  
8 may be necessary and remains unexpended at the close of  
9 business on June 30, 2015, from a reappropriation heretofore  
10 made for such purposes in Section 10 of Article 1 of Public  
11 Act 98-0675, is reappropriated from the Capital Development  
12 Fund to the Office of the Architect of the Capitol for  
13 remodeling, planning, relocation, permanent equipment, and  
14 other related expenses, including architectural and  
15 engineering fees associated with construction, for the  
16 remodeling of office space and other support areas under the  
17 jurisdiction of the House of Representatives and the Senate.

18 Section 15. The sum of \$31,908,920, or so much thereof  
19 as may be necessary and remains unexpended at the close of  
20 business on June 30, 2015, from a reappropriation heretofore  
21 made for such purpose in Article 1, Section 15 of Public Act  
22 98-0675, as amended, is reappropriated from the Capital  
23 Development Fund to the Office of the Architect of the

1 Capitol for all costs associated with capital upgrades and  
2 improvements.

3 Section 20. The following named amounts, or so much  
4 thereof as may be necessary, and remain unexpended at the  
5 close of business on June 30, 2015, from reappropriations  
6 heretofore made for such purposes in Article 1, Section 20 of  
7 Public Act 98-0675, as amended, are reappropriated from the  
8 Capital Development Fund to the Office of the Architect of  
9 the Capitol for the projects hereinafter enumerated:

2 Section 5. The sum of \$9,628,778, or so much thereof as  
3 may be necessary and remains unexpended at the close of  
4 business on June 30, 2015, from a reappropriation heretofore  
5 made in Article 5, Section 200 of Public Act 98-0675, as  
6 amended, is reappropriated from the Build Illinois Bond Fund  
7 to the Department of Commerce and Economic Opportunity for a  
8 grant to Aspira, Inc. of Illinois for costs associated with  
9 acquisition, construction, rehabilitation, renovation and  
10 equipping facilities, including prior incurred costs.

11 Section 25. The sum of \$1,125,000, or so much thereof as  
12 may be necessary and remains unexpended at the close of  
13 business on June 30, 2015, from a reappropriation heretofore  
14 made for such purpose in Article 5, Section 260 of Public Act  
15 98-0675, as amended, is reappropriated from the Build  
16 Illinois Bond Fund to the Department of Commerce and Economic  
17 Opportunity for a grant to the Cook County Health and  
18 Hospital System for costs associated with medical equipment  
19 and capital improvements at Provident Hospital.

20 Section 30. No contract shall be entered into or  
21 obligation incurred or any expenditure made from any

1 appropriation herein made in this Article until after the  
2 purpose and amounts have been approved in writing by the  
3 Governor.

4 Total, this Article \$10,753,778

5 ARTICLE 3

6 DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY

7 Section 5. The amount of \$750,000, or so much thereof as  
8 may be necessary and remains unexpended at the close of  
9 business on June 30, 2015, from an appropriation heretofore  
10 made in Article 6, Section 15 of Public Act 98-0675, as  
11 amended, is reappropriated from the Build Illinois Bond Fund  
12 to the Department of Commerce and Economic Opportunity for a  
13 grant to Erie Neighborhood House.

14 Section 10. No contract shall be entered into or  
15 obligation incurred or any expenditure made from any  
16 appropriation herein made in this Article until after the  
17 purpose and amounts have been approved in writing by the  
18 Governor.

## 1 ARTICLE 4

## 2 DEPARTMENT OF NATURAL RESOURCES

3 Section 5. The sum of \$1,141,224, or so much thereof as  
4 may be necessary and remains unexpended at the close of  
5 business on June 30, 2015, from an appropriation heretofore  
6 made in Article 8, Section 85, of Public Act 98-0675, as  
7 amended, is reappropriated from the State Parks Fund to the  
8 Department of Natural Resources, in coordination with the  
9 Capital Development Board, for the development of the World  
10 Shooting and Recreation Complex including all construction  
11 and debt service expenses required to comply with this  
12 appropriation. Provided further, to the extent that revenues  
13 are received for such purposes, said revenues must come from  
14 non-State sources.

15  
16 Section 10. No contract shall be entered into or  
17 obligation incurred or any expenditure made from an  
18 appropriation herein made in this Article until after the  
19 purpose and the amount of such expenditure has been approved  
20 in writing by the Governor.

## 1 AERONAUTICS

2 Section 10. The sum of \$110,000,000, or so much thereof  
3 as may be necessary, is appropriated from the  
4 Federal/State/Local Airport Fund to the Department of  
5 Transportation for funding airport improvement projects,  
6 including reimbursements and/or refunds, undertaken pursuant  
7 to pertinent state or federal laws.

## 8 PUBLIC TRANSPORTATION

9 Section 15. The sum of \$20,000,000, or so much thereof  
10 as may be necessary, is appropriated from the Federal Mass  
11 Transit Trust Fund to the Department of Transportation for  
12 the federal share of capital, operating, consultant services,  
13 and technical assistance grants, as well as state  
14 administration and interagency agreements, provided such  
15 amounts shall not exceed funds to be made available from the  
16 Federal Government.

17 Section 20. The sum of \$1,700,000, or so much thereof as  
18 may be necessary, is appropriated from the State Rail Freight  
19 Loan Repayment Fund to the Department of Transportation for  
20 funding the State Rail Freight Loan Repayment Program created  
21 by Section 49.25g-1 of the Civil Administrative Code of  
22 Illinois.

1 Section 25. The sum of \$250,000, or so much thereof as  
2 may be necessary, is appropriated from the Rail Freight Loan  
3 Repayment Fund to the Department of Transportation for the  
4 Rail Freight Service Assistance Program, created by Section  
5 49.25a through 49.25g-1 of the Civil Administrative Code of  
6 Illinois.

7 Section 30. The sum of \$4,500,000, or so much thereof as  
8 may be necessary, is appropriated from the Working Capital  
9 Revolving Loan Fund to the Department of Transportation for  
10 the purpose of making loans to disadvantaged business  
11 enterprises certified by IDOT for participation on IDOT-  
12 procured construction and construction-related projects under  
13 the provisions of the Disadvantaged Business Revolving Loan  
14 Program pursuant to Section 610 of the Department of  
15 Transportation Law.

22 contract costs of construction, including reconstruction,  
23 extension and improvement of State highways, arterial

1 highways, roads, access areas, roadside shelters, rest areas  
 2 fringe parking facilities and sanitary facilities and such  
 3 other purposes as provided by the "Illinois Highway Code";  
 4 for purposes allowed or required by Title 23 of the U.S.  
 5 Code; for bikeways as provided by Public Act 78-850; for land  
 6 acquisition and signboard removal and control, junkyard  
 7 removal and control and preservation of natural beauty; and  
 8 for capital improvements which directly facilitate an  
 9 effective vehicle weight enforcement program, such as scales  
 10 (fixed and portable), scale pits and scale installations and  
 11 scale houses, in accordance with applicable laws and

17 reappropriation heretofore made in Article 12, Section 5 and  
18 Article 13, Section 5 of Public Act 98-0675, as amended, is  
19 reappropriated from the Road Fund to the Department of

1 Transportation for Permanent Improvements to Illinois  
2 Department of Transportation facilities, including but not  
3 limited to the purchase of land, construction, repair,  
4 alterations and improvements to maintenance and traffic

4 reappropriated from the Road Fund to the Department of  
5 Transportation for repair of damages by motorists to highway  
6 guardrails, fencing, lighting units, bridges, underpasses,  
7 signs, traffic signals, crash attenuators, landscaping,  
8 roadside shelters, rest areas, fringe parking facilities,  
9 sanitary facilities, maintenance facilities including salt  
10 storage buildings, vehicle weight enforcement facilities

18 as may be necessary, and remains unexpended at the close of  
19 business on June 30, 2015, from the appropriation and  
20 reappropriation heretofore made in Article 12, Section 15 and  
21 Article 13, Section 35 of Public Act 98-0675, as amended, is  
22 reappropriated from the Road Fund to the Department of  
23 Transportation for apportionment to counties for construction  
24 of township bridges 20 feet or more in length as provided in

1 Section 6-901 through 6-906 of the "Illinois Highway Code".

2 AERONAUTICS

3 Section 40. The sum of \$673,496,616, or so much thereof  
4 as may be necessary, and remains unexpended at the close of  
5 business on June 30, 2015, from the appropriation and  
6 reappropriation heretofore made in Article 12, Section 20 and  
7 Article 13, Section 45 of Public Act 98-0675, as amended, is  
8 reappropriated from the Federal/State/Local Airport Fund to  
9 the Department of Transportation for funding the local or  
10 federal share of airport improvement projects, including  
11 reimbursements and/or refunds, undertaken pursuant to  
12 pertinent state or federal laws, provided such amounts shall  
13 not exceed funds available from federal and/or local sources.

14 Section 45. The sum of \$19,233,057, or so much thereof  
15 as may be necessary, and remains unexpended at the close of  
16 business on June 30, 2015, from the reappropriation  
17 heretofore made in Article 13, Section 50 of Public Act 98-  
18 0675, as amended, is reappropriated from the Transportation  
19 Bond Series B Fund to the Department of Transportation for  
20 such purposes as are described in Section 34 of the Illinois  
21 Aeronautics Act, as amended, and Section 72 of the Illinois  
22 Aeronautics Act, as amended, for airport improvements.

2 Section 50. The sum of \$368,962, or so much thereof as  
3 may be necessary, and remains unexpended at the close of  
4 business on June 30, 2015, from the reappropriation  
5 heretofore made in Article 13, Section 55 of Public Act 98-  
6 0675, as amended, is reappropriated from the Transportation  
7 Bond Series B Fund to the Department of Transportation for  
8 construction costs, making grants and providing project  
9 assistance to municipalities, special transportation  
10 districts, private non-profit carriers, mass transportation  
11 carriers, and the Intercity Rail Program for the acquisition,  
12 construction, extension, reconstruction, and improvement of  
13 mass transportation facilities, including rapid transit,  
14 intercity rail, bus and other equipment used in connection  
15 therewith, as provided by law, for the counties of Cook,  
16 DuPage, Kane, Lake, McHenry and Will, pursuant to Section  
17 4(b)(2) of the General Obligation Bond Act, as amended.

18 Section 55. The following named sums, or so much thereof  
19 as may be necessary, and remains unexpended at the close of  
20 business on June 30, 2015, from the reappropriations  
21 heretofore made in Article 13, Section 60 of Public Act 98-  
22 0675, as amended, are reappropriated from the Transportation  
23 Bond Series B Fund to the Department of Transportation for  
24 construction costs, making grants and providing project

1 assistance to municipalities, special transportation  
 2 districts, private non-profit carriers, mass transportation

3 Bond Series B Fund to the Department of Transportation to

17 Bond Series B Fund to the Department of Transportation for  
18 construction costs, making grants and providing project  
19 assistance to municipalities, special transportation  
20 districts, private non-profit carriers, mass transportation  
21 carriers and the Intercity rail program for the acquisition,  
22 construction, extension, reconstruction, and improvement of  
23 mass transportation facilities, including rapid transit,
