### SYNOPSIS AS INTRODUCED:

Amends the Metropolitan Water Reclamation District Act. Provides that the executive director of the board of the District shall appoint an administrative services officer with the advice and consent of the board. Further provides that the administrative services officer is not included within the classified civil service. Effective immediately.

# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Metropolitan Water Reclamation District Act 5 is amended by changing Sections 4 and 4.13 as follows:

6 (70 ILCS 2605/4) (from Ch. 42, par. 323)

7 Sec. 4. The commissioners elected under this Act constitute 8 a board of commissioners for the district by which they are elected, which board of commissioners is the corporate 9 authority of the sanitary district, and, in addition to all 10 other powers specified in this Act, shall establish the 11 policies and goals of the sanitary district. The executive 12 director, in addition to all other powers specified in this 13 14 Act, shall manage and control all the affairs and property of the sanitary district and shall regularly report to the Board 15 of Commissioners on the activities of the sanitary district in 16 executing the policies and goals established by the board. At 17 the regularly scheduled meeting of odd numbered years following 18 19 the induction of new commissioners the board of commissioners 20 elect from its own number a president shall and a 21 vice-president to serve in the absence of the president, and the chairman of the committee on finance. The board shall 22 provide by rule when a vacancy occurs in the office of the 23

- president, vice-president, or the chairman of the committee on finance and the manner of filling such vacancy.
- 3 The board shall appoint from outside its own number the 4 executive director and treasurer for the district.

5 The executive director must be a resident of the sanitary 6 district and a citizen of the United States. He must be 7 selected solely upon his administrative and technical 8 qualifications and without regard to his political 9 affiliations.

In the event of illness or other prolonged absence, death or resignation creating a vacancy in the office of the executive director, or treasurer, the board of commissioners may appoint an acting officer from outside its own number, to perform the duties and responsibilities of the office during the term of the absence or vacancy.

16 The executive director, with the advice and consent of the 17 board of commissioners, shall appoint the director of engineering, director of maintenance and operations, director 18 19 of human resources, director of procurement and materials 20 management, clerk, general counsel, director of monitoring and research, and director of information technology. These 21 22 constitute the heads of the Department of Engineering, 23 Maintenance and Operations, Human Resources, Procurement and 24 Materials Management, Finance, Law, Monitoring and Research, and Information Technology, respectively. No other departments 25 26 or heads of departments may be created without subsequent

amendment to this Act. All such department heads are under the
 direct supervision of the executive director.

The executive director, with the advice and consent of the 3 board of commissioners, shall appoint a public 4 and intergovernmental affairs officer 5 and an administrative services officer. The public and intergovernmental affairs 6 7 officer shall and administrative services officer serve under 8 the direct supervision of the executive director.

9 The director of human resources must be qualified under 10 Section 4.2a of this Act.

11 The director of procurement and materials management must 12 be selected in accordance with Section 11.16 of this Act.

13 In the event of illness or other prolonged absence, death 14 or resignation creating a vacancy in the office of director of 15 engineering, director of maintenance and operations, director 16 of human resources, director of procurement and materials 17 management, clerk, general counsel, director of monitoring and research, public and intergovernmental affairs officer, 18 19 administrative services officer, or director of information technology, the executive director shall appoint an acting 20 officer to perform the duties and responsibilities of the 21 22 office during the term of the absence or vacancy. Any such 23 officers appointed in an acting capacity are under the direct supervision of the executive director. 24

All appointive officers and acting officers shall give bondas may be required by the board.

1 The executive director, treasurer, acting executive 2 director, and acting treasurer hold their offices at the 3 pleasure of the board of commissioners.

The acting director of engineering, acting director of 4 5 maintenance and operations, acting director of human resources, acting director of procurement and materials 6 7 management, acting clerk, acting general counsel, acting 8 director of monitoring and research, acting public and 9 intergovernmental affairs officer, acting administrative 10 services officer, and acting director of information 11 technology hold their offices at the pleasure of the executive 12 director.

13 The director of engineering, director of maintenance and 14 operations, director of human resources, director of 15 procurement and materials management, clerk, general counsel, 16 director of monitoring and research, public and 17 intergovernmental affairs officer, administrative services officer , and director of information technology may be removed 18 19 from office for cause by the executive director. Prior to 20 removal, such officers are entitled to a public hearing before the executive director at which hearing they may be represented 21 22 by counsel. Before the hearing, the executive director shall 23 notify the board of commissioners of the date, time, place and 24 nature of the hearing.

In addition to the general counsel appointed by the executive director, the board of commissioners may appoint from

1 outside its own number an attorney, or retain counsel, to 2 advise the board of commissioners with respect to its powers 3 and duties and with respect to legal questions and matters of 4 policy for which the board of commissioners is responsible.

5 The executive director is the chief administrative officer 6 of the district, has supervision over and is responsible for 7 all administrative and operational matters of the sanitary 8 district including the duties of all employees which are not 9 otherwise designated by law, and is the appointing authority as 10 specified in Section 4.11 of this Act.

11 The board, through the budget process, shall set the 12 compensation of all the officers and employees of the sanitary 13 district. Any incumbent of the office of president may appoint 14 an administrative aide which appointment remains in force 15 during his incumbency unless revoked by the president.

16 Effective upon the election in January, 1985 of the 17 president and vice-president of the board of commissioners and the chairman of the committee on finance, the annual salary of 18 the president shall be \$37,500 and shall be increased to 19 20 \$39,500 in January, 1987, \$41,500 in January, 1989, \$50,000 in January, 1991, and \$60,000 in January, 2001; the annual salary 21 22 of the vice-president shall be \$35,000 and shall be increased 23 to \$37,000 in January, 1987, \$39,000 in January, 1989, \$45,000 in January, 1991, and \$55,000 in January, 2001; the annual 24 25 salary of the chairman of the committee on finance shall be \$32,500 and shall be increased to \$34,500 in January, 1987, 26

1 \$36,500 in January, 1989, \$45,000 in January, 1991, and \$55,000
2 in January, 2001.

3 The annual salaries of the other members of the Board shall
4 be as follows:

5 For the three members elected in November, 1980, \$26,500 6 per annum for the first two years of the term; \$28,000 per 7 annum for the next two years of the term and \$30,000 per annum 8 for the last two years.

9 For the three members elected in November, 1982, \$28,000 10 per annum for the first two years of the term and \$30,000 per 11 annum thereafter.

For members elected in November, 1984, \$30,000 per annum.

For the three members elected in November, 1986, \$32,000 for each of the first two years of the term, \$34,000 for each of the next two years and \$36,000 for the last two years;

For three members elected in November, 1988, \$34,000 for each of the first two years of the term and \$36,000 for each year thereafter.

For members elected in November, 1990, 1992, 1994, 1996, or
1998, \$40,000.

For members elected in November, 2000 and thereafter, \$50,000.

Notwithstanding the other provisions of this Section, the board, prior to January 1, 2007 and with a two-thirds vote, may increase the annual rate of compensation at a separate flat amount for each of the following: the president, the - 7 - LRB099 17271 AWJ 41629 b

vice-president, the chairman of the committee on finance, and the other members; the increased annual rate of compensation shall apply to all such officers and members whose terms as members of the board commence after the increase in compensation is adopted by the board.

The board of commissioners has full power to pass all 6 necessary ordinances, orders, rules, 7 resolutions and 8 regulations for the proper management and conduct of the 9 business of the board of commissioners and the corporation and 10 for carrying into effect the object for which the sanitary 11 district is formed. All ordinances, orders, rules, resolutions 12 and regulations passed by the board of commissioners must, before they take effect, be approved by the president of the 13 14 board of commissioners. If he approves thereof, he shall sign 15 them, and such as he does not approve he shall return to the 16 board of commissioners with his objections in writing at the 17 next regular meeting of the board of commissioners occurring after the passage thereof. Such veto may extend to any one or 18 more items or appropriations contained in any ordinance making 19 an appropriation, or to the entire ordinance. If the veto 20 extends to a part of such ordinance, the residue takes effect. 21 22 If the president of such board of commissioners fails to return 23 any ordinance, order, rule, resolution or regulation with his 24 objections thereto in the time required, he is deemed to have 25 approved it, and it takes effect accordingly. Upon the return 26 of any ordinance, order, rule, resolution, or regulation by the

president, the vote by which it was passed must be reconsidered by the board of commissioners, and if upon such reconsideration two-thirds of all the members agree by yeas and nays to pass it, it takes effect notwithstanding the president's refusal to approve thereof.

It is the policy of this State that all powers granted, 6 7 either expressly or by necessary implication, by this Act or 8 any other Illinois statute to the District may be exercised by 9 the District notwithstanding effects on competition. It is the 10 intention of the General Assembly that the "State action 11 exemption" to the application of federal antitrust statutes be 12 fully available to the District to the extent its activities are authorized by law as stated herein. 13

16 Sec. 4.13. The following offices and places of employment, insofar as there are or may be such in the sanitary district, 17 shall not be included within the classified civil service: All 18 19 elective officers, the director of human resources, the clerk, treasurer, director of engineering, general counsel, executive 20 21 director, director of maintenance and operations, director of 22 procurement and materials management, director of monitoring 23 and research, director of information technology, public and 24 intergovernmental affairs officer, administrative services 25 officer, and secretary and administrative aide to the president

of the board of trustees, members of the civil service board 1 2 and special examiners appointed by the civil service board and the secretaries to the officers and individual trustees, and 3 those employed for periods not exceeding 5 years under any 4 5 apprentice program, training or intern programs funded wholly or in part by grants from the State of Illinois or the United 6 7 States of America. Further, apprentices in a sanitary district 8 apprenticeship program for the trades shall not be included 9 within the classified civil service. Entry into a sanitary 10 district apprenticeship program for the trades shall be by 11 lottery. Graduates of a sanitary district apprenticeship 12 program for the trades shall be given additional points, in an 13 amount to be determined by the Director of Human Resources, on examinations for civil service journeymen positions in the 14 15 trades at the sanitary district.
