SYNOPSIS AS INTRODUCED:

105 ILCS 5/2-3.66

Amends the School Code. Makes a technical change in a Section concerning truants' alternative and optional education programs.

1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by changing Section
2-3.66 as follows:

6 (105 ILCS 5/2-3.66) (from Ch. 122, par. 2-3.66)

Sec. 2-3.66. Truants' alternative and optional education 7 projects to 8 programs. То establish offer modified 9 instructional programs or other services designed to prevent students from dropping out of school, including programs 10 pursuant to Section 2-3.41, and and to serve as a part time or 11 full time option in lieu of regular school attendance and to 12 award grants to local school districts, educational service 13 14 regions or community college districts from appropriated funds to assist districts in establishing such projects. 15 The 16 education agency may operate its own program or enter into a 17 contract with another not-for-profit entity to implement the program. The projects shall allow dropouts, up to and including 18 age 21, potential dropouts, including truants, uninvolved, 19 20 unmotivated and disaffected students, as defined by State Board 21 Education rules and regulations, to enroll, as of an 22 alternative to regular school attendance, in an optional education program which may be established by school board 23

policy and is in conformance with rules adopted by the State 1 2 Truants' Alternative and Board of Education. Optional 3 Education programs funded pursuant to this Section shall be planned by a student, the student's parents or legal quardians, 4 5 unless the student is 18 years or older, and school officials and shall culminate in an individualized optional education 6 7 plan. Such plan shall focus on academic or vocational skills, 8 or both, and may include, but not be limited to, evening 9 school, summer school, community college courses, adult 10 education, preparation courses for high school equivalency 11 testing, vocational training, work experience, programs to 12 enhance self concept and parenting courses. School districts 13 which are awarded grants pursuant to this Section shall be 14 authorized to provide day care services to children of students 15 who are eligible and desire to enroll in programs established 16 and funded under this Section, but only if and to the extent 17 that such day care is necessary to enable those eligible students to attend and participate in the programs and courses 18 which are conducted pursuant to this Section. School districts 19 20 and regional offices of education may claim general State aid under Section 18-8.05 for students enrolled in truants' 21 22 alternative and optional education programs, provided that 23 such students are receiving services that are supplemental to a 24 program leading to a high school diploma and are otherwise 25 eligible to be claimed for general State aid under Section 26 18-8.05.
