Section 5. The Election Code is amended by adding Sections
4-8.5, 5-8.5, and 6-35.5 as follows:

7 Sec. 4-8.5. Deputy registrar eligibility; pre-registration. Unless otherwise provided by law, an 8 9 individual that is 17 years old or older who is registered to vote in this State shall be eligible to serve as a deputy 10 registrar. Notwithstanding any other provision of law to the 11 12 contrary, an individual who will be 18 years of age or older at the next general election may sign and circulate candidate 13 14 petitions and may pre-register to vote, and shall be deemed competent to execute and attest to any voter registration 15 forms, with the registration held in abeyance by the 16 appropriate election authority until such time as that 17 individual attains the required age to vote. 18

Notwithstanding any other provision of law to the 15 16 contrary, an individual who will be 18 years of age or older at the next general election may sign and circulate candidate 17 18 petitions and may pre-register to vote, and shall be deemed competent to execute and attest to any voter registration 19 forms, with the registration held in abeyance by the 20 21 appropriate election authority until such time as that individual attains the required age to vote. 22

23 Section 10. The Township Code is amended by adding Section
24 45-65 as follows:

2	Sec. 45-65. Voting age. Notwithstanding any other
3	provision of law, a person who is 17 years old on the date of a
4	caucus or primary election and who is otherwise qualified to
5	vote is qualified to vote at that caucus or primary, including
6	voting a vote by mail, grace period, or early voting ballot
7	with respect to that primary, if that person will be 18 years
8	old on the date of the corresponding election.
9	References in this Article and elsewhere to the requirement
10	that a person must be 18 years old to vote shall be interpreted
11	in accordance with this Section.
12	For the purposes of this Article, an individual who is 17
13	years of age and who will be 18 years of age on the date of the
14	general election shall be deemed competent to execute and
15	attest to any voter registration forms.
