A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. "Operational expenses" defined. For the
6 purposes of this Act, the term "operational expenses"
7 includes the following items:

- 8 (a) Personal Services;
- 9 (b) State contributions to Social Security
- 10 (c) Group Insurances;
- 11 (d) Contractual Services
- 12 (e) Travel;
- 13 (f) Commodities;
- 14 (g) Printing;
- 15 (h) Equipment;
- 16 (i) Electronic data processing;
- 17 (j) Telecommunications services;
- 18 (k) Operation of automotive equipment;
- 19 (l) Refunds;
- 20 (m) Employee retirement contributions paid by the employer;
- 21 (n) Permanent improvements;
- 22 (o) Deposits to other funds.

1 Section 5. The sum of \$16,826,500, or so much thereof as
2 may be necessary, is appropriated from the General Revenue
3 Fund to the Board of Trustees of the University of Illinois
4 for costs and expenses related to or in support of the
5 Prairie Research Institute, in accordance with Public Act 95-
6 0728.

7 Section 10. The sum of \$45,000,000, or so much thereof
8 as may be necessary, is appropriated from the General Revenue
9 Fund to the Board of Trustees of the University of Illinois
10 for operating costs and expenses related to or in support of
11 the University of Illinois Hospital.

12 Section 15. The amount of \$455,922,500, or so much
13 thereof as may be necessary, is appropriated from the
14 Education Assistance Fund to the Board of Trustees of the
15 University of Illinois to meet its operational expenses for
16 the fiscal year ending June 30, 2017.

17 Section 20. The sum of \$3,816,200, or so much thereof as
18 may be necessary, is appropriated from the Fire Prevention
19 Fund to the Board of Trustees of the University of Illinois
20 for the purpose of maintaining the Illinois Fire Service
21 Institute, paying the Institute's expenses, and providing the

1 facilities and structures incident thereto, including payment
2 to the University for personal services and related costs
3 incurred.

4 Section 25. The sum of \$250,000, or so much thereof as
5 may be necessary, is appropriated from the State College and
6 University Trust Fund to the Board of Trustees of the
7 University of Illinois for scholarship grant awards.

8 Section 30. The sum of \$200,000, or so much thereof as
9 may be necessary, is appropriated from the Emergency Public
10 Health Fund to the University of Illinois for costs and
11 expenses related to or in support of Emergency Mosquito
12 Abatement.

13 Section 35. The sum of \$200,000, or so much thereof as
14 may be necessary, is appropriated from the Used Tire
15 Management Fund to the University of Illinois for costs and
16 expenses related to or in support of mosquito research and
17 abatement.

18 Section 40. The sum of \$500,000, or so much thereof as
19 may be necessary, is appropriated from the Hazardous Waste
20 Research Fund to the University of Illinois for its ordinary
21 and contingent expenses.

1 Section 99. Effective date. This Act takes effect July 1,
2 2016, if and only if Senate Bill 2789 of the 99th General
3 Assembly (the Unbalanced Budget Response Act), as introduced
4 in the Illinois Senate, becomes law.
