1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated from the
8 Insurance Producer Administration Fund to the Department of
9 Insurance:

4 Section 5. The sum of \$500,000, or so much thereof as
5 may be necessary, is appropriated from the Insurance Producer
6 Administration Fund to the Department of Insurance for costs
7 and expenses related to or in support of a Regulatory/G&A
8 Shared Services Center.

9 Section 10. The sum of \$1,000,000, or so much thereof as
10 may be necessary, is appropriated from the Insurance Producer
11 Administration Fund to the Department of Insurance for costs
12 and expenses related to or in support of Get Covered
13 Illinois.

14 Section 15. The sum of \$750,000, or so much thereof as
15 may be necessary, is appropriated from the Insurance Producer
16 Administration Fund to the Department of Insurance for costs
17 and expenses related to or in support of the agency's
18 operations.

19 Section 20. The following named amounts, or so much
20 thereof as may be necessary, respectively, for the objects
21 and purposes hereinafter named, are appropriated from the

19 Section 25. The sum of \$250,000, or so much thereof as
 20 may be necessary, is appropriated from the Insurance
 21 Financial Regulation Fund to the Department of Insurance for
 22 costs and expenses related to or in support of the agency's
 23 operations.

1 Section 30. The sum of \$100,000, or so much thereof as
 2 may be necessary, is appropriated from the George Bailey
 3 Memorial Fund to the Department of Insurance for grants and
 4 expenses related to or in support of the George Bailey
 5 Memorial Program.

6 Section 35. The following named amounts, or so much
 7 thereof as may be necessary, respectively, for the objects
 8 and purposes hereinafter named, are appropriated from the
 9 Public Pension Regulation Fund to the Department of
 10 Insurance:

1 Section 40. The sum of \$500,000, or so much thereof as
2 may be necessary, is appropriated from the Public Pension
3 Regulation Fund to the Department of Insurance for costs and
4 expenses related to or in support of the agency's operations.

5 Section 45. The sum of \$950,000, or so much thereof as
6 may be necessary, is appropriated from the Illinois Workers'
7 Compensation Commission Operations Fund to the Department of
8 Insurance for costs associated with the administration and
9 operations of the Insurance Fraud Division of the Illinois
10 Workers' Compensation Commission's anti-fraud program.

11 Section 99. Effective Date. This Act takes effect July
12 1, 2016, if and only if Senate Bill 2789 of the 99th General
13 Assembly (the Unbalanced Budget Response Act), as introduced
14 in the Illinois Senate, becomes law.
