HOUSE RESOLUTION

2           WHEREAS, The members of the Illinois House of  
3 Representatives are saddened to learn of the death of Tim  
4 Stetenfeld; and

5           WHEREAS, Tim Stetenfeld was an award-winning financial  
6 advisor with the Plainfield office of Edward Jones Investments,  
7 the household-oriented retirement planning and investment  
8 services firm, from 2004 to 2015; he was a recipient of the  
9 Ovation to Business Award from former Illinois State  
10 Representative Tom Cross and his Business Advisory Committee in  
11 June of 2012; Mr. Stetenfeld and Edward Jones Investments were  
12 also the presenters of Plainfield's Concerts in the Park, the  
13 free music and concert program at Settlers Park in Plainfield;

15           WHEREAS, Tim Stetenfeld was a board member and past  
16 chairman of the board of the Plainfield Area Chamber of  
17 Commerce; he also served as chairperson of the Plainfield  
18 Advisory Task Force on Economic Development, which advises the  
19 Village of Plainfield on growth and planning issues; and

20           WHEREAS, Tim Stetenfeld was a fundraising organizer and  
21 co-chairman of the Greater Joliet Area YMCA's Giving Gala, a  
22 Will County-oriented annual community event that provides help

1 for persons and families seeking financial access to local YMCA  
2 programs; the 2014 Giving Gala, co-led by Mr. Stetenfeld,  
3 notched a 37% increase in proceeds from the 2013 Gala; the next  
4 Giving Gala is scheduled for February 28, 2015, at the  
5 Bolingbrook Golf Club; and

6 WHEREAS, Tim Stetenfeld served as president of the  
7 Plainfield Kiwanis Club in 2008; he was also a senior member of  
8 the Plainfield Rotary Club and a parishioner and Eucharistic  
9 minister at St. Mary Immaculate Parish in Plainfield; and

10 WHEREAS, Tim Stetenfeld is survived by his wife, Cathy  
11 Stetenfeld; his mother, Arlene Stetenfeld; and 2 siblings,  
12 Ernie Stetenfeld, III and Sandi Stetenfeld Diana; therefore, be
