1 AMENDMENT TO SENATE BILL 250

2 AMENDMENT NO. _____. Amend Senate Bill 250 as follows:

3 on page 3, line 11, after "agency.", by inserting "The agency
4 shall inform the individual that the identity of the designated
5 government agency transferring voter registration information
6 is confidential."; and

7 on page 3, line 13, after "status." by inserting "The agency
8 shall collect all needed information for voter registration.";
9 and

10 on page 3, by replacing lines 17 through 19 with "identity,
11 address, and citizenship. The Secretary of State's Driver
12 Services Department shall send this information to the State
13 Board of Elections for every applicant, regardless of whether
14 or not the individual attested to his or her eligibility to
15 register to vote. All other designated government agencies

1 shall send this information to the State Board of Elections
2 only if the individual attested that he or she is eligible to
3 register to vote. The State Board of Elections shall
4 electronically"; and

5 on page 4, line 12, by replacing "all individuals" with "any
6 individual"; and

7 on page 4, line 13, by replacing "are" each time it appears
8 with "is"; and

9 on page 4, lines 17 and 18, by replacing "they provided an
10 attestation" with "the individual attested to his or her
11 eligibility to register to vote"; and

12 on page 4, by replacing lines 19 through 24 with "authority
13 shall process the application accordingly."; and

14 on page 5, line 1, after "agency", by inserting "of an
15 individual who attested to his or her eligibility to register
16 to vote"; and

17 on page 5, line 10, by replacing "registration applications"
18 with "eligibility requirements"; and

19 on page 5, line 13, after "Illinois," by inserting "then"; and

1 on page 6, by replacing lines 8 and 9 with "unless he or she
2 declines registration"; and

3 on page 6, by replacing lines 15 through 19 with the following:

4 "(5) a statement (i) notifying the applicant to opt out
5 if he or she does not meet the qualifications to be a voter
6 by returning a prepaid postcard, opting out online, or
7 otherwise contacting the appropriate election authority
8 and (ii) stating that the applicant does not have to
9 provide a reason he or she is declining voter registration
10 or disclose citizenship status."; and

11 on page 8, line 8, after "voter,", by inserting "then"; and

12 on page 8, line 11, after "authority,", by inserting "then";
13 and

14 on page 9, line 11, after "registration,", by inserting "then";
15 and

16 on page 9, line 15, after "registration,", by inserting "then";
17 and

18 on page 10, line 11, by replacing "their" with "his or her
19 ~~their~~"; and

1 on page 10, line 12, immediately after "identification", by
2 adding "that complies with the federal Help America Vote Act of
3 2002"; and

4 by deleting line 24 on page 11 through line 10 on page 12; and

5 on page 13, lines 17 and 18, by deleting "Subsection (c-5) of
6 this Section shall be implemented no later than September 1,
7 2016."; and

8 on page 13, by replacing lines 20 through 23 with "implemented
9 no later than January 1, 2018."; and

10 by replacing line 21 on page 17 through line 4 on page 18 with
11 the following:

12 "identification card shall be notified, under the procedures
13 set forth in Section 1A-16.6 of the Election Code, that his or
14 her personal information shall be transferred to the State
15 Board of Elections for the purpose of creating an electronic
16 voter registration application, and that the individual will
17 only be registered to vote if he or she meets the
18 qualifications to register to vote in Illinois. ~~that the person~~
19 ~~may apply to register to vote at such station and may also~~
20 ~~apply to transfer his or her voter registration at such station~~
21 ~~to a different address in the State.~~ Such notification may be

1 made in writing or verbally issued by an employee or the
2 Secretary of State.".
