2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Line of Duty Compensation Act is amended by
changing Section 2 as follows:

6 (820 ILCS 315/2) (from Ch. 48, par. 282)

Sec. 2. As used in this Act, unless the context otherwiserequires:

9 (a) "Law enforcement officer" or "officer" means any person employed by the State or a local governmental entity as a 10 policeman, peace officer, auxiliary policeman or in some like 11 position involving the enforcement of the law and protection of 12 the public interest at the risk of that person's life. This 13 14 includes supervisors, wardens, superintendents and their assistants, guards and keepers, correctional officers, youth 15 16 supervisors, parole agents, aftercare specialists, school 17 teachers and correctional counsellors in all facilities of both the Department of Corrections and the Department of Juvenile 18 19 Justice, while within the facilities under the control of the 20 Department of Corrections or the Department of Juvenile Justice 21 or in the act of transporting inmates or wards from one 22 location to another or while performing their official duties, and all other Department of Correction or Department of 23

1 Juvenile Justice employees who have daily contact with inmates.

2 The death of the foregoing employees of the Department of Corrections or the Department of Juvenile Justice in order to 3 be included herein must be by the direct or indirect willful 4 5 act of an inmate, ward, work-releasee, parolee, aftercare releasee, parole violator, aftercare release violator, person 6 7 under conditional release, or any person sentenced or 8 committed, or otherwise subject to confinement in or to the 9 Department of Corrections or the Department of Juvenile 10 Justice.

11 (b) "Fireman" means any person employed by the State or a 12 local governmental entity as, or otherwise serving as, a member 13 or officer of a fire department either for the purpose of the 14 prevention or control of fire or the underwater recovery of 15 drowning victims, including volunteer firemen.

16 (c) "Local governmental entity" includes counties,17 municipalities and municipal corporations.

18 (d) "State" means the State of Illinois and its
19 departments, divisions, boards, bureaus, commissions,
20 authorities and colleges and universities.

(e) "Killed in the line of duty" means losing one's life as a result of injury received in the active performance of duties as a law enforcement officer, civil defense worker, civil air patrol member, paramedic, fireman, or chaplain if the death occurs within one year from the date the injury was received and if that injury arose from violence or other accidental SB1941 Engrossed - 3 - LRB099 08774 JLS 28943 b

cause. In the case of a State employee, "killed in the line of 1 2 duty" means losing one's life as a result of injury received in 3 the active performance of one's duties as a State employee, if the death occurs within one year from the date the injury was 4 5 received and if that injury arose from a willful act of violence by another State employee committed during such other 6 7 employee's course of employment and after January 1, 1988. The 8 term excludes death resulting from the willful misconduct or 9 intoxication of the officer, civil defense worker, civil air 10 patrol member, paramedic, fireman, chaplain, or State 11 employee. However, the burden of proof of such willful 12 misconduct or intoxication of the officer, civil defense worker, civil air patrol member, paramedic, fireman, chaplain, 13 14 or State employee is on the Attorney General. Subject to the 15 conditions set forth in subsection (a) with respect to inclusion under this Act of Department of Corrections and 16 17 Department of Juvenile Justice employees described in that subsection, for the purposes of this Act, instances in which a 18 law enforcement officer receives an injury in the active 19 20 performance of duties as a law enforcement officer include but are not limited to instances when: 21

(1) the injury is received as a result of a wilful act of violence committed other than by the officer and a relationship exists between the commission of such act and the officer's performance of his duties as a law enforcement officer, whether or not the injury is received SB1941 Engrossed - 4 - LRB099 08774 JLS 28943 b

while the officer is on duty as a law enforcement officer;

2 (2) the injury is received by the officer while the 3 officer is attempting to prevent the commission of a 4 criminal act by another or attempting to apprehend an 5 individual the officer suspects has committed a crime, 6 whether or not the injury is received while the officer is 7 on duty as a law enforcement officer;

8 (3) the injury is received by the officer while the 9 officer is travelling to or from his employment as a law 10 enforcement officer or during any meal break, or other 11 break, which takes place during the period in which the 12 officer is on duty as a law enforcement officer.

13 In the case of an Armed Forces member, "killed in the line 14 of duty" means losing one's life while on active duty in 15 connection with the September 11, 2001 terrorist attacks on the 16 United States, Operation Enduring Freedom, or Operation Iraqi 17 Freedom.

In the case of a <u>law enforcement officer</u>, fireman, 18 volunteer fireman, or paramedic, "killed in the line of duty" 19 20 also includes instances in which the injury received by the law enforcement officer, fireman, volunteer fireman, or paramedic 21 22 is self-inflicted and a medical professional establishes that 23 the injury was a result of the law enforcement officer's, fireman's, volunteer fireman's, or paramedic's active duty 24 25 service.

26 (f) "Volunteer fireman" means a person having principal

employment other than as a fireman, but who is carried on the 1 2 rolls of a regularly constituted fire department either for the purpose of the prevention or control of fire or the underwater 3 recovery of drowning victims, the members of which are under 4 5 the jurisdiction of the corporate authorities of a city, 6 village, incorporated town, or fire protection district, and 7 includes a volunteer member of a fire department organized 8 under the "General Not for Profit Corporation Act", approved 9 July 17, 1943, as now or hereafter amended, which is under 10 contract with any city, village, incorporated town, fire 11 protection district, or persons residing therein, for fire 12 fighting services. "Volunteer fireman" does not mean an 13 individual who volunteers assistance without being regularly 14 enrolled as a fireman.

(g) "Civil defense worker" means any person employed by the State or a local governmental entity as, or otherwise serving as, a member of a civil defense work force, including volunteer civil defense work forces engaged in serving the public interest during periods of disaster, whether natural or man-made.

(h) "Civil air patrol member" means any person employed by the State or a local governmental entity as, or otherwise serving as, a member of the organization commonly known as the "Civil Air Patrol", including volunteer members of the organization commonly known as the "Civil Air Patrol".

26 (i) "Paramedic" means an Emergency Medical

Technician-Paramedic certified by the Illinois Department of 1 2 Public Health under the Emergency Medical Services (EMS) 3 Act, and all other emergency medical personnel Systems certified by the Illinois Department of Public Health who are 4 5 members of an organized body or not-for-profit corporation 6 under the jurisdiction of a city, village, incorporated town, 7 fire protection district or county, that provides emergency 8 medical treatment to persons of a defined geographical area.

9 (j) "State employee" means any employee as defined in 10 Section 14-103.05 of the Illinois Pension Code, as now or 11 hereafter amended.

(k) "Chaplain" means an individual who:

(1) is a chaplain of (i) a fire department or (ii) a police department or other agency consisting of law enforcement officers; and

16 (2) has been designated a chaplain by (i) the fire
17 department, police department, or other agency or an
18 officer or body having jurisdiction over the department or
19 agency or (ii) a labor organization representing the
20 firemen or law enforcement officers.

(1) "Armed Forces member" means an Illinois resident who is: a member of the Armed Forces of the United States; a member of the Illinois National Guard while on active military service pursuant to an order of the President of the United States; or a member of any reserve component of the Armed Forces of the United States while on active military service pursuant to an SB1941 Engrossed - 7 - LRB099 08774 JLS 28943 b
