

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The amount of \$1,411,700, or so much thereof  
6 as may be necessary, is appropriated from the General Revenue  
7 Fund to the Governor's Office of Management and Budget to  
8 meet its operational expenses for the fiscal year ending June  
9 30, 2016.

10 Section 10. The amount of \$1,543,100, or so much thereof  
11 as may be necessary, is appropriated from the Capital  
12 Development Fund to the Governor's Office of Management and  
13 Budget for ordinary and contingent expenses associated with  
14 the sale and administration of General Obligation bonds.

15 Section 15. The amount of \$650,000, or so much thereof  
16 as may be necessary, is appropriated from the Build Illinois  
17 Bond Fund to the Governor's Office of Management and Budget  
18 for ordinary and contingent expenses associated with the sale  
19 and administration of Build Illinois bonds.

1           Section 20.     The amount of \$446,000,000, or so much  
2     thereof as may be necessary, is appropriated from the Build  
3     Illinois Bond Retirement and Interest Fund to the Governor's  
4     Office of Management and Budget for the purpose of making  
5     payments to the Trustee under the Master Indenture as defined  
6     by and pursuant to the Build Illinois Bond Act.

7           Section 25.     The amount of \$113,400, or so much thereof  
8     as may be necessary, is appropriated from the School  
9     Infrastructure Fund to the Governor's Office of Management  
10    and Budget for operational expenses related to the School  
11    Infrastructure Program.

12          Section 30.     The sum of \$14,000,000, or so much thereof  
13    as may be necessary, is appropriated from the Illinois Civic  
14    Center Bond Retirement and Interest Fund to the Governor's  
15    Office of Management and Budget for the principal and  
16    interest and premium, if any, on Limited Obligation Revenue  
17    bonds issued pursuant to the Metropolitan Civic Center  
18    Support Act.

19          Section 35.     No contract shall be entered into or  
20    obligation incurred for any expenditures from the  
21    appropriations made in Sections 10, 15 and 20 until after the  
22    purposes and amounts have been approved in writing by the

1 Governor.

2 Section 40. The sum of \$3,100,000, or so much thereof as  
 3 may be necessary, is appropriated from the Grant  
 4 Accountability and Transparency Fund to the Governor's Office  
 5 of Management and Budget for all costs associated with the  
 6 implementation and administration of the Grant Accountability  
 7 and Transparency Act, including refunds and prior year costs.

8 ARTICLE 2

9 Section 5. The following named amounts, or so much  
 10 thereof as may be necessary, respectively, are appropriated  
 11 to the Court of Claims for its ordinary and contingent  
 12 expenses:

8 Section 10. The amount of \$450,000, or so much of that  
9 amount as may be necessary, is appropriated from the Court of  
10 Claims Administration and Grant Fund to the Court of Claims  
11 for administrative expenses under the Crime Victims  
12 Compensation Act.

13 Section 15. The following named amounts, or so much of  
14 that amount as may be necessary, are appropriated to the  
15 Court of Claims for payment of claims as follows:

16 For claims under the Crime Victims  
17 Compensation Act:

20 Section 20. The amount of \$1,000,000, or so much thereof  
21 as may be necessary, is appropriated from the General Revenue  
22 Fund to the Court of Claims for payment of awards solely as a

1 result of the lapsing of an appropriation originally made  
2 from any funds held by the State Treasurer.

3 Section 25. The sum of \$5,000,000, or so much thereof as  
4 may be necessary, is appropriated from the General Revenue  
5 Fund to the Court of Claims for payment of line of duty  
6 awards.

7 Section 30. The following named amounts, or so much  
8 thereof as may be necessary, is appropriated to the Court of  
9 Claims for payment of claims as follows:

10 For claims under the Crime Victims

11 Compensation Act:

12 Payable from General Revenue Fund .....6,000,000

13 For claims other than Crime Victims:

14 Payable from the General Revenue Fund .....9,807,400

16 Section 35. The following named amounts, or so much of

11 ARTICLE 3

12 Section 5. In addition to other sums appropriated, the  
13 sum of \$11,339,000, or so much thereof as may be necessary,  
14 is appropriated from the General Revenue Fund to the State  
15 Board of Elections for operational expenses, grants, and  
16 reimbursements for the fiscal year ending June 30, 2016.

17 Section 10. The following amounts, or so much of those  
18 amounts as may be necessary, respectively, are appropriated  
19 from the Personal Property Tax Replacement Fund to the State  
20 Board of Elections for its ordinary and contingent expenses  
21 as follows:

 14 may be necessary, are reappropriated from the Help Illinois  
 15 Vote Fund to the State Board of Elections for Implementation  
 16 of the Help America Vote Act of 2002:

20	For the implementation of the Statewide	
21	Voter Registration System as required by

6 ARTICLE 4

7 Section 5. In addition to other sums appropriated, the  
8 sum of \$344,821,200, or so much thereof as may be necessary,  
9 is appropriated from the General Revenue Fund to the Supreme  
10 Court for operational expenses, awards, grants, permanent  
11 improvements and probation reimbursements for the fiscal year  
12 ending June 30, 2016.

13 Section 10. The sum of \$27,451,000, or so much thereof  
14 as may be necessary, is appropriated from the Mandatory  
15 Arbitration Fund to the Supreme Court for Mandatory  
16 Arbitration Programs.

17 Section 15. The sum of \$667,900, or so much thereof as  
18 may be necessary, is appropriated from the Foreign Language  
19 Interpreter Fund to the Supreme Court for the Foreign  
20 Language Interpreter Program.



1 Section 20. The sum of \$973,000, or so much thereof as  
2 may be necessary, is appropriated from the Lawyers'  
3 Assistance Program Fund to the Supreme Court for lawyers'  
4 assistance programs.

5 Section 25. The sum of \$1,500,000, or so much thereof as  
6 may be necessary, is appropriated from the Supreme Court  
7 Special Purposes Fund to the Supreme Court for the oversight  
8 and management of electronic filing, case management systems,  
9 and committees and commissions of the Supreme Court.

10 ARTICLE 5

11 Section 5. The sum of \$10,000,000, or so much thereof as  
12 may be necessary, is appropriated from the Supreme Court  
13 Historic Preservation Fund to the Supreme Court Historic  
14 Preservation Commission for historic preservation purposes.

15 ARTICLE 6

16 Section 5. The amount of \$88,100, or so much thereof as  
17 may be necessary, is appropriated from the General Revenue  
18 Fund to the State Employees' Retirement System to meet its  
19 operational expenses for the fiscal year ending June 30,  
20 2016.

1 Section 10. The following named amounts, or so much  
 2 thereof as may be necessary, respectively, are appropriated  
 3 from the General Revenue Fund for the objects and purposes  
 4 hereinafter named to meet the ordinary and contingent  
 5 expenses of the State Employees' Retirement System:

6 CENTRAL OFFICE

7 For Employee Retirement Contributions

8 Paid by Employer for Prior Fiscal Years .....0

9 ARTICLE 7

10 Section 5. The sum of \$132,060,000, or so much thereof  
 11 as may be necessary, is appropriated from the General Revenue  
 12 Fund to the Board of Trustees of the Judges Retirement System  
 13 of Illinois for the State's contribution, as provided by law.

14 Section 10. The sum of \$16,073,000, or so much thereof  
 15 as may be necessary, is appropriated from the General Revenue  
 16 Fund to the Board of Trustees of the General Assembly  
 17 Retirement System for the State's contribution, as provided  
 18 by law.

19 ARTICLE 999

1           Section 999. Effective date. This Act takes effect July 1,
