

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$610,000, or so much thereof as
6 may be necessary, is appropriated from the General Revenue
7 Fund to the Deaf and Hard of Hearing Commission for
8 operational expenses of the fiscal year ending June 30, 2016.

9 Section 10. The sum of \$200,000, or so much thereof as
10 may be necessary, is appropriated from the Interpreters for
11 the Deaf Fund to the Deaf and Hard of Hearing commission for
12 administration and enforcement of the Interpreter for the
13 Deaf Licensure Act of 2007.

14 ARTICLE 2

15 Section 5. The sum of \$9,384,000, or so much thereof as
16 may be necessary, is appropriated from the General Revenue
17 Fund to the Guardianship and Advocacy Commission for
18 operational expenses of the fiscal year ending June 30, 2016.

1 Section 10. The sum of \$2,300,000, or so much thereof as
2 may be necessary, is appropriated from the Guardianship and
3 Advocacy Fund to the Guardianship and Advocacy Commission for
4 services pursuant to Section 5 of the Guardianship and
5 Advocacy Act.

6 ARTICLE 3

7 Section 5. The sum of \$9,106,400, or so much thereof as
8 may be necessary, is appropriated from the General Revenue
9 Fund to the Department of Human Rights for operational
10 expenses of the fiscal year ending June 30, 2016.

11 Section 10. The sum of \$73,500, or so much thereof as
12 may be necessary, is appropriated from the General Revenue
13 Fund to the Department of Human Rights for the purpose of
14 funding expenses associated with the Commission on
15 Discrimination and Hate Crimes as provided in Public Act 95-
16 0425.

17 Section 15. The sum of \$350,000, or so much thereof as
18 may be necessary, is appropriated from the Department of
19 Human Rights Training and Development Fund to the Department
20 of Human Rights for the purpose of funding expenses
21 associated with administration.

1 Section 20. The following named sums, or so much thereof
 2 as may be necessary, respectively, are appropriated from the
 3 Special Projects Division Fund:

16 Section 25. The sum of \$978,200, or so much thereof as
 17 may be necessary, is appropriated from the General Revenue
 18 Fund to the Department of Human Rights for expenses relating
 19 to the investigation and processing of human rights cases,
 20 and expenses associated with Elementary and Higher Education
 21 processing.

22 Section 30. The sum of \$500,000, or so much thereof as

1 may be necessary, is appropriated from the Department of
 2 Human Rights Special Fund to the Department of Human Rights
 3 for the purpose of funding expenses associated with the
 4 Department of Human Rights.

5 ARTICLE 4

6 Section 5. The following named amounts, or so much
 7 thereof as may be necessary, respectively, are appropriated
 8 to the Human Rights Commission for the objects and purposes
 9 hereinafter enumerated:

1 may be necessary, is appropriated from the General Revenue
 2 Fund to the Human Rights Commission for the Illinois Torture
 3 Inquiry Relief Commission.

4 ARTICLE 5

5 Section 5. The following named amounts, or so much
 6 thereof as may be necessary, respectively, are appropriated
 7 for the objects and purposes hereinafter named, to meet the
 8 ordinary and contingent expenses of the Illinois Council on
 9 Developmental Disabilities:

7 to community agencies and other State agencies.
