2 AMENDMENT NO. _____. Amend Senate Bill 2038, AS AMENDED, by
3 inserting the following in its proper numeric sequence:

4 "ARTICLE 3

5 Section 5. The sum of \$25,459,400 or so much thereof as
6 may be necessary is appropriated from the Education
7 Assistance Fund to the Board of Trustees of Chicago State
8 University for ordinary and contingent expenses for the
9 fiscal year ending June 30, 2016.

10 ARTICLE 4

11 Section 5. The sum of \$30,116,100 or so much thereof as
12 may be necessary is appropriated from the Education

1 Assistance Fund to the Board of Trustees of Eastern Illinois
2 University for ordinary and contingent expenses for the
3 fiscal year ending June 30, 2016.

4 ARTICLE 5

5 Section 5. The sum of \$16,862,000 or so much thereof as
6 may be necessary is appropriated from the Education
7 Assistance Fund to the Board of Trustees of Governors State
8 University for ordinary and contingent expenses for the
9 fiscal year ending June 30, 2016.

10 ARTICLE 6

11 Section 5. The sum of \$50,614,500 or so much thereof as
12 may be necessary is appropriated from the Education
13 Assistance Fund to the Board of Trustees of Illinois State
14 University for ordinary and contingent expenses for the
15 fiscal year ending June 30, 2016.

16 ARTICLE 7

17 Section 5. The sum of \$25,857,700 or so much thereof as
18 may be necessary is appropriated from the Education
19 Assistance Fund to the Board of Trustees of Northeastern

1 Illinois University for ordinary and contingent expenses for
2 the fiscal year ending June 30, 2016.

3 ARTICLE 8

4 Section 5. The sum of \$63,835,300 or so much thereof as
5 may be necessary is appropriated from the Education
6 Assistance Fund to the Board of Trustees of Northern Illinois
7 University for ordinary and contingent expenses for the
8 fiscal year ending June 30, 2016.

9 ARTICLE 9

10 Section 5. The sum of \$139,775,100 or so much thereof as
11 may be necessary is appropriated from the Education
12 Assistance Fund to the Board of Trustees of Southern Illinois
13 University for ordinary and contingent expenses for the
14 fiscal year ending June 30, 2016.

15 ARTICLE 10

16 Section 1. The sum of \$391,704,200 or so much thereof as
17 may be necessary is appropriated from the Education
18 Assistance Fund to the Board of Trustees of University of
19 Illinois for ordinary and contingent expenses for the fiscal

1 year ending June 30, 2016.

2 ARTICLE 11

3 Section 5. The sum of \$36,051,400 or so much thereof as
4 may be necessary is appropriated from the Education
5 Assistance Fund to the Board of Trustees of Western Illinois
6 University for ordinary and contingent expenses for the
7 fiscal year ending June 30, 2016.”.
