- 18 Section 275. The sum of \$0, or so much thereof as may be
- 19 necessary, is appropriated to the Office of the Secretary of
- 20 State from the 4-H Fund for grants to the Illinois 4-H
- 21 foundation for the purpose of funding 4-H programs in Illinois.

- 1 Section 280. The sum of \$15,000, or so much thereof as
- 2 may be necessary, is appropriated to the Office of
- Secretary of State from the Fraternal Order of Police Fund for 3
- grants to the Illinois Fraternal Order of Police to increase 4
- the efficiency and professionalism of law enforcement officers 5
- 6 in Illinois, to educate the public about law enforcement
- issues, to more firmly establish the public confidence in law 7
- enforcement, to create partnerships with the public, and to 8
- honor the service of law enforcement officers. 9
- 10 Section 285. The sum of \$45,000, or so much thereof as
- may be necessary, is appropriated to the Secretary of State 11
- 12 from the Share the Road Fund for grants to the League of
- 13 Illinois Bicyclists, a not for profit corporation, for
- educational programs instructing bicyclists and motorists how 14
- 15 to legally and more safely share the roadways.
- 16 Section 290. The sum of \$3,500, or so much thereof as
- may be necessary, is appropriated to the Office of the 17
- Secretary of State from the St. Jude Children's Research Fund 18
- 19 for grants to St. Jude Children's Research Hospital for
- 20 pediatric treatment and research.
- Section 295. The sum of \$10,000, or so much thereof as 21
- 22 may be necessary, is appropriated to the Office of the

- 1 Secretary of State from the Ducks Unlimited Fund for grants to
- 2 Ducks Unlimited, Inc. to fund wetland protection, enhancement,
- and restoration projects in the State of Illinois, to fund 3
- education and outreach for media, volunteers, members, and the 4
- general public regarding waterfowl and wetlands conservation in 5
- 6 the State of Illinois, and to cover reasonable cost for Ducks
- Unlimited plate advertising and administration of the wetland 7
- 8 conservation projects and education program.
- 9 Section 300. The sum of \$200,000, or so much thereof as
- 10 may be necessary, is appropriated to the Secretary of State
- from the Family Responsibility Fund for all costs associated 11
- 12 with enforcement of the Family Financial Responsibility Law.
- 13 Section 305. The sum of \$0, or so much thereof as may be
- 14 necessary, is appropriated to the Office of the Secretary of
- 15 State from the Soil and Water Conservation District Fund for
- 16 grants to Illinois soil and water conservation districts for
- 17 projects that conserve and restore soil and water in Illinois.
- 18 Section 310. The sum of \$5,000, or so much thereof as may
- 19 be necessary, is appropriated to the Office of the Secretary of
- 20 State from the Illinois State Police Memorial Park Fund for
- 21 grants to the Illinois State Police Heritage Foundation, Inc.
- 22 for building and maintaining a memorial and park, holding an

- 1 annual memorial commemoration, giving scholarships to children
- of State police officers killed or catastrophically injured in 2
- the line of duty, and providing financial assistance to police 3
- officers and their families when a police officer is killed or 4
- injured in the line of duty. 5

Section 315. The sum of \$5,000, or so much thereof as may 6

be necessary, is appropriated to the Office of the Secretary of 7

8 State from the Illinois Sheriffs' Association Scholarship and

Training Fund for grants to the Illinois Sheriffs' Association 9

10 for scholarships obtained in a competitive process to attend

the Illinois Teen Institute or an accredited college or 11

12 university, for programs designed to benefit the elderly and

13 teens, and for law enforcement training.
