1 AMENDMENT TO SENATE BILL 2323

2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 2323 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The Mosquito Abatement District Act is amended  
5 by adding Section 11a as follows:

6 (70 ILCS 1005/11a new)

7 Sec. 11a. Dissolution of DuPage County mosquito abatement  
8 districts. On the effective date of this amendatory Act of the  
9 99th General Assembly:

10 (a) all mosquito abatement districts in DuPage County are  
11 dissolved and discontinued and all the rights, powers, duties,  
12 assets, property, liabilities, obligations, and  
13 responsibilities of each mosquito abatement district shall  
14 vest in and be assumed by the township in which the mosquito  
15 abatement district is located. If the mosquito abatement  
16 district is located in more than one township, each township

1 which contains any part of the mosquito abatement district  
2 shall assume the rights, powers, duties, assets, property,  
3 liabilities, obligations, and responsibilities of that part of  
4 the mosquito abatement district located within its territory.

5 If a parcel of property owned by the mosquito abatement  
6 district is located in more than one township, all townships in  
7 which any portion of the property lies shall determine and  
8 agree on the use or dividing of the property; and if all  
9 townships in which any portion of the property lies cannot  
10 agree on the use or dividing of the property then the county  
11 board shall determine the use or dividing of the property;

12 (b) all trustees of a dissolved mosquito abatement district  
13 shall cease to hold office. Each district board of trustees  
14 created under subsection (d) shall exercise all duties and  
15 responsibilities of the trustees of each dissolved mosquito  
16 abatement district or part of a district for which a township  
17 assumed responsibility;

18 (c) each township board of trustees shall assume all taxing  
19 authority of each dissolved mosquito abatement district or part  
20 of a district dissolved for which a township assumed  
21 responsibility under this Section; and

22 (d) new mosquito abatement districts are created in each  
23 township of DuPage county. In each township of DuPage County,  
24 the supervisor, assessor, and highway commissioner, or their  
25 designees, shall serve as the board of the mosquito abatement  
26 district in that township. Each mosquito abatement district

1 created under this Section, and each board created under this  
2 subsection (d), shall have all the rights, powers, duties,  
3 obligations, and responsibilities of any mosquito abatement  
4 district or board created under this Act including, but not  
5 limited to, the ability to levy and collect taxes under this  
6 Act."
